The County of San Diego Department of Environmental Health Solid Waste Local Enforcement Agency (LEA) received and has accepted for filing an application package for a modification to the Solid Waste Facility Permit (SWFP) for SANCO Resource Recovery. The LEA is certified by the California Department of Resources Recycling and Recovery to enforce state laws and regulations at solid waste facilities within the County of San Diego excluding the City of San Diego.

<u>Description of Proposed Permit Modification:</u> The operator has submitted an application package to modify its Solid Waste Facility Permit. The proposed SWFP modification will provide non-material updates to the SWFP. The permit modification will not result in an increase of hours of operations or permitted daily tonnage.

<u>LEA Findings:</u> The LEA has reviewed and considered the information, including the environmental effects of modifying this Solid Waste Facility Permit. A Mitigated Negative Declaration (MND) SCH No. 2005061105, adopted by the City of Lemon Grove Planning Commission on July 25, 2005 was filed with the State Clearinghouse. No substantial changes are proposed in the project and the LEA finds that there are no significant environmental effects arising out of the issuance of this modified Solid Waste

Facility Permit. A Notice of Exemption will be filed with the San Diego County Clerk and the State Clearinghouse.
