# A. CONTINUING REVIEW OF THE FOREST CONSERVATION INITIATIVE (FCI)

- Item was previously discussed at 2-14-12 meeting. Minutes for 2-14-12 incorrectly identified the designation requested by Corte Madera property owner as RV2. It should be SR2.
- Presentation by Owners of Bar SR Ranch on request for RL20 designation for APN 5271500100.

Group discussed unique circumstances for this property including; adjacent land uses on private and tribal land are similar or higher densities; only 1 additional lot would result; it would not impact ground water resources; it would be consistent with adjacent commonly owned parcel; property only abuts National Forest on one side; property previously had higher density designation;

MOTION: Recommend approval of owners request to designate Parcel 5271500100 as RL20 to be consistent with the adjacent commonly owned property in the Mountain Empire Planning Area
