#### 7. UNFINISHED BUSINESS

A. County Parks and Recreation construction manager Sean O'Neill will discuss the county general fund money used to design the future Pine Valley ball field construction project.

Project design has been completed. Project as designed is estimated to cost \$1.7M to construct. There is only \$373,000 of existing funding. Staff now feels that additional funding is not likely to be found in the near future and we should consider using the remaining funds on other projects at the park. Staff is suggesting alternate projects to use the existing funds on.

- Install artificial turf on one existing field (\$475,000)
- Repair surface in playground
- Repair and paint fence
- Shade structures for play area
- Replace cooking tables
- Upgrade pavilion
- Ball field bleacher shade structures
- Additional trees to replace the dead oaks
- Walking trail
- Fitness course
- Walking trail into adjacent Open Space

Item will be trailed to next agenda to get public input on what improvements we should request and to inquire with Supervisor Dianne Jacob and Park & Rec Management on ability to find additional funding.

# B. Continuing discussion of the SDGE Mountain Empire Training Facility at 30763 Old Highway 80.

Proposal to raise existing berms 3 feet to meet county noise requirements at property line and remove limits on hours of operation. This will also result in visually hiding the existing buildings from the roadway.
