SUBJECT: **FEES FOR JULY 1, 2024 – JUNE 30, 2025**

The Department of Agriculture/Weights & Measures (AWM) is committed to providing services that support public health and safety, a resilient food supply, agricultural trade, consumer confidence, and a sustainable environment at the lowest costs possible.

Our fee increases for Fiscal Year 2024-2025 are necessary to address cost increases and comply with San Diego County Board of Supervisors (Board) policy of maintaining cost recovery for all our programs. We review these fees annually as a commitment to making cost recovery a regular part of our operations and provide notice to impacted customers so they can plan for any increases.

After completing our annual cost review and receiving Board approval, the following fee adjustments are **effective July 1, 2024**.
