1. SUBJECT: JUVENILE JUSTICE: ADVANCING THE COMPREHENSIVE STRATEGY FOR YOUTH, FAMILY, AND THE COMMUNITY (DISTRICTS: ALL)

OVERVIEW:

Juvenile crime is at the lowest point in decades, resulting in a considerable decline in juvenile arrests and juveniles on probation in recent years.

Due to the significant downtrend in juvenile delinquency, and consequently the reduction of youth under County supervision and in custody, it is an opportune time to reassess the spectrum of juvenile justice services that make up the County of San Diego's Comprehensive Strategy for Youth, Family and the Community. As County staff contemplates related adjustments to juvenile probation facilities, it is incumbent upon this board to set policy to redirect cost savings back into the juvenile justice system.

Today's actions would direct the Chief Administrative Officer to determine whether a portion of cost savings related to this downward trend may be redirected toward strengthening the continuum of services that make up the County Comprehensive Strategy for Youth, Family and the Community.

FISCAL IMPACT:

There is no fiscal impact associated with this action. Following the Chief Administrative Officer's (CAO) review, recommendations regarding actions in support of the County Comprehensive Strategy for Youth, Family and the Community may be included in the Fiscal Year 2015-17 CAO Recommended Operational Plan.

2. SUBJECT: SHERIFF - REQUEST TO ESTABLISH APPROPRIATIONS FOR THE 2014 PAUL COVERDELL FORENSIC SCIENCE IMPROVEMENT PROGRAM GRANT (DISTRICTS: ALL)

OVERVIEW:

This is a request to establish appropriations of \$37,235 in grant funding from the California Governor's Office of Emergency Services (Cal OES) for the 2014 Paul Coverdell Forensic Science Improvement Program. This program awards funds to the State of California Crime Laboratories, Medical Examiners and Coroners to improve quality, timeliness, and credibility of forensic science over current operations. During the project period October 1, 2014, to August 31, 2015, the grant award will be used for the continuing education of 17 forensic scientists at the Sheriff's Regional Forensic Crime Laboratory.

FISCAL IMPACT:

Funds for this request are not included in the Fiscal Year 2014-15 Operational Plan for the Sheriff's Department. If approved, this request will result in current year direct costs and revenue of \$37,235. The funding source is grant revenue from California Governor's Office of Emergency Services. This grant award recovers all Sheriff's Department direct costs but does not reimburse costs associated with administrative overhead and support. There is no local match requirement for this grant. There will be no change in net General Fund cost and no additional staff years.

OVERVIEW:

In accordance with Board of Supervisors Policy D-7, Out-of-County Business and Related Guidelines and Processes, this is a request for one Deputy Sheriff to attend the Regional Hostage and Crisis Negotiators Course in Norwich, England from May 10, 2015, through May 15, 2015.

FISCAL IMPACT:

Funds for this request are included in the Fiscal Year 2014-15 Operational Plan for the Sheriff's Department. A portion of the travel costs, estimated at \$1,663, will be covered by the Norfolk Constabulary. If approved, this request will result in approximately \$1,842 current year costs. The funding source is General Purpose Revenue. The Deputy Sheriff will receive regular salary and benefits and no overtime will be incurred as a result of this trip. There will be no change in net General Fund cost and no additional staff years.

4. SUBJECT: IMPLEMENTATION OF CALIFORNIA WELFARE AND INSTITUTIONS CODE SECTIONS 5345 ET SEQ., LAURA'S LAW, TO PROVIDE ASSISTED OUTPATIENT TREATMENT TO PERSONS WITH SERIOUS MENTAL ILLNESS (DISTRICTS: ALL)

OVERVIEW:

The Behavioral Health Services (BHS) department of the County of San Diego Health and Human Services Agency (HHSA) provides a wide range of behavioral health programs for persons with serious mental illness that include outreach and engagement services, outpatient, intensive case management, emergency response services, acute hospital care and long term care services.

In 2002, the California Legislature passed Assembly Bill 1421, Laura's Law, now codified as Welfare and Institutions Code Section 5345 *et seq.*, to provide California counties an option to implement court-ordered services to individuals with serious mental illness. The law specifies rigorous eligibility criteria and use of the Assisted Outpatient Treatment (AOT) model of services. Until now, only four California counties have adopted a Laura's Law program and are providing services. Three other counties have adopted a Laura's Law program but are not yet providing services.

Pursuant to the Board of Supervisors' direction on September 27, 2011 (7), as an alternative to a Laura's Law program, the County of San Diego began offering similar services through the In-Home Outreach Team (IHOT) program, first as a pilot program in three of the six HHSA regions. With further Board direction on July 30, 2013 (6), IHOT was expanded county-wide. IHOT serves individuals who are resistant to mental health treatment and who potentially meet Laura's Law's eligibility criteria.

The Board has closely monitored the IHOT program and data suggest an increasingly high percentage of individuals referred to the IHOT program appear to meet Laura's Law criteria and are considered potential Laura's Law candidates. In response to this documentation of greater need, and with legislative changes to identify funding, on January 27, 2015 (3), the Board directed staff to return in 90 days with an implementation plan for Laura's Law in San Diego County. Laura's Law/AOT services will be funded through undesignated Mental Health Services Act (MHSA) revenue and Federal Financial Participation (FFP) revenue, and will result in no reduction to existing mental health services as required by Laura's Law.

FISCAL IMPACT:

There is no current year fiscal impact associated with the proposed actions, as the execution of a contract will not occur until Fiscal Year 2015-16. If approved, this request will result in annual costs and revenue of \$2,291,280 for the Health and Human Services Agency (HHSA). The funding sources for the HHSA costs are Mental Health Services Act (MHSA) revenue and Federal Financial Participation (FFP) revenue. There will be no change in net General Fund cost and no additional staff years. Costs to the Sheriff's Department and Office of the Public Defender for transportation, court activity and security, and court representation will be determined based on experience following implementation. Staff will return to the Board with recommendations for funding as necessary.

6. SUBJECT: NEIGHBORHOOD REINVESTMENT PROGRAM GRANTS (DISTRICT: 4)

OVERVIEW:

The County's fiscal condition has enabled it to reinvest taxpayer money in our communities for the benefit of the public. These recommended actions propose allocations to new projects from the County of San Diego's Neighborhood Reinvestment Project Funds.

FISCAL IMPACT:

The fiscal impact of these recommendations is \$440,720. Funds for this request are included in the Fiscal Year 2014-2015 Adopted Operational Plan for the Neighborhood Reinvestment Program (15665). The funding source is General Fund fund balance. There will be no change in net General Fund costs and no additional staff years.

- 1. Allocate \$5,000 from the Neighborhood Reinvestment Program Budget (org 15665) to the Alliance for Quality Education for its District 6 Night Market to assist in the cost of printing promotional materials such as programs, brochures, posters and banners, the purchase of tents, lights, trash bags, cleaning supplies, volunteers T-shirts, cups, utensils and the professional installation of lighting and banners.
- 2. Allocate \$25,000 from the Neighborhood Reinvestment Program Budget (org 15665) to the Turning Point Home toward the purchase of a 12 passenger van.
- 3. Allocate \$24,300 from the Neighborhood Reinvestment Program Budget (org 15665) to Catholic Charities to assist in the cost of renovating the medical screening facility at its Rachel's Women's Center with new cabinets, countertops, a medical screening table, door knobs, window repair, program supplies such as paper towels and toilet paper and cleaning supplies.
- 4. Allocate \$25,000 from the Neighborhood Reinvestment Program Budget (org 15665) to the Children's Initiative to assist in the purchase of upgrades to its technology system, including new computers, auxiliary computer equipment, hardware, software, cabling, a server, data storage software and website update.
- 5. Allocate \$20,000 from the Neighborhood Reinvestment Program Budget (org 15665) to the Community Information Exchange to assist in the purchase and creation of custom secure file transfer software that, with client consent, will enable the sharing of a client's social services program history among participating social service and care providers.

- 6. Allocate \$25,000 from the Neighborhood Reinvestment Program Budget (org 15665) to the Ilan-lael Art Education Foundation to assist in completing the second phase of building the James Hubell Arts Center's office and kitchen space.
- 7. Allocate \$25,000 from the Neighborhood Reinvestment Program Budget (org 15665) to La Maestra Community Health Centers to purchase computers, auxiliary computer equipment, software and hardware, tablets, video cameras, printers, workstations, furniture, routers and servers for its computer lab to expand opportunities for students to gain experience for future careers through STEAM-based activities.
- 8. Allocate \$25,000 from the Neighborhood Reinvestment Program Budget (org 15665) to Mainly Mozart to assist in the purchase of printed materials such as brochures, signage, website improvements, technology and production equipment, computers, camera/video equipment; and office equipment such as desks, storage units, and filing cabinets.
- 9. Allocate \$20,000 from the Neighborhood Reinvestment Program Budget (org 15665) to Mission Edge San Diego to assist in the purchase of office and conference room furniture, computers, auxiliary computer equipment, hardware and software.
- 10. Allocate \$40,000 from the Neighborhood Reinvestment Program Budget (org 15665) to the Neighborhood House Association to assist in the purchase of kitchen equipment and capital improvements such as flooring, plumbing, roofing, HVAC system and fire sprinkler/alarm system for the association's new central kitchen at 7818 Wilkerson Ct.
- 11. Allocate \$20,000 from the Neighborhood Reinvestment Program Budget (org 15665) to the Ocean Discovery Institute for the construction and permitting costs associated with its new Living Lab at 4255 Thorn Street in City Heights.
- 12. Allocate \$25,000 from the Neighborhood Reinvestment Program Budget (org 15665) to the Phoenix House to purchase and install two backup emergency generators and exterior building repairs at the Phoenix House Academy in Descanso.
- 13. Allocate \$5,000 from the Neighborhood Reinvestment Program Budget (org 15665) to Photocharity to purchase musical instruments, art supplies, blankets and backpacks for the organization's "Taking Music & Arts to the Street" program.
- 14. Allocate \$50,000 from the Neighborhood Reinvestment Program Budget (org 15665) to Pro Kids Golf Academy to purchase and install new lighting and upgrades to its Golf Simulator computer system including software, a camera system, screen, lighting and air conditioning.

- 15. Allocate \$20,000 from the Neighborhood Reinvestment Program Budget (org 15665) to the San Diego Museum of Man to assist in the purchase of shelving for its collections, workshop tools to build exhibits, a work truck, commercial refrigerator/freezer, folding tables and a storage cart.
- 16. Allocate \$11,420 from the Neighborhood Reinvestment Program Budget (org 15665) to the San Diego Regional Fire Foundation to purchase participant materials, workbooks, registration and certification materials, branding materials and printing costs associated with the L-580 Leadership in Action Interactive Case Study.
- 17. Allocate \$20,000 from the Neighborhood Reinvestment Program Budget (org 15665) to San Diego Second Chance for plumbing, roofing and window improvements at its sober living facilities located at 5054 Westover place and 3517 Central Avenue.

7. SUBJECT: SAN DIEGO UNIFIED SCHOOL DISTRICT 2015 GENERAL OBLIGATION BONDS AND 2015 GENERAL OBLIGATION REFUNDING BONDS (DISTRICTS: 1, 2, 3, 4)

OVERVIEW:

2015 General Obligation Bonds

A bond election was duly called and held in the San Diego Unified School District, County of San Diego, California ("District") on November 4, 2008 pursuant to Section 15100 et seq. of the Education Code of the State of California. Approximately 69% of those voters casting ballots authorized the issuance of general obligation bonds of the District in the maximum aggregate principal amount of \$2.1 billion ("2008 Authorization").

On April 14, 2015, the Board of Education of the District ("District Board") adopted a resolution ("District Resolution") requesting that the County, on behalf of the District, sell bonds under the 2008 Authorization to be designated the "San Diego Unified School District 2015 General Obligation Bonds (Dedicated Unlimited Ad Valorem Property Tax Bonds) (Election of 2008, Series H)" in one or more series in a not to exceed par amount of \$40,000,000 ("2015 Bonds"). Prior to the 2015 Bonds, the District has issued, or caused to be issued on its behalf, approximately \$589,996,188 under the 2008 Authorization via nine series Subsequent to the issuance of the 2015 Bonds, approximately \$1,470,003,812 of the 2008 Authorization will remain. Proceeds of the 2015 Bonds will be used for authorized school purposes. The District has received a qualified certification in its most recent interim report and thereby has requested that the County sell the 2015 Bonds on its behalf as required by Section 15140 of The District has appointed the County Treasurer-Tax the Education Code. Collector ("Treasurer") as Paying Agent on the 2015 Bonds.

2015 General Obligation Refunding Bonds

Concurrently with the sale of the 2015 Bonds, the District has determined that it is financially prudent to refund certain of its outstanding general obligation bonds issued under authorization ("1998 Authorization") granted at an election held within the District on November 3, 1998, at which the requisite two-thirds or more authorized the issuance of general obligation bonds in the maximum aggregate principal amount of \$1.51 billion ("Bonds"). The outstanding amount of general obligation bonds issued under the 1998 Authorization that the District is considering refunding total approximately \$201,335,000. The District is authorized to and will be issuing the 2015 Refunding Bonds on its own behalf, but has appointed the County Treasurer as Paying Agent on the 2015 Refunding Bonds.

Today's recommendation will: (1) authorize issuance of the 2015 Bonds by the County on behalf of the District; (2) approve the form and authorize the execution of documents required for the issuance of the 2015 Bonds; (3) approve the form and authorize the execution of a Fourth Supplemental Paying Agent Agreement, which will authorize the Treasurer to accept the District's appointment as Paying Agent on the 2015 Bonds and the 2015 Refunding Bonds; and (4) approve the form and authorize the execution of an Investment Management Agreement.

FISCAL IMPACT:

The Bonds will be general obligations of the San Diego Unified School District to be paid from ad valorem property taxes levied within the boundaries of the District, and do not constitute an obligation of the County.

OVERVIEW:

On April 7, 2015 (19), the Board introduced the Ordinance for further consideration and adoption on April 21, 2015.

These recommendations present amendments to the Compensation Ordinance for the first reading of negotiated provisions of Memoranda of Agreement (MOA) extensions between the County of San Diego and the San Diego County Deputy District Attorneys Association (DDAA), the San Diego Deputy County Counsels Association (SDDCCA), and the Public Defender Association of San Diego County (PDA).

A summary of the proposed Compensation Ordinance amendments is as follows:

- 1. Eliminates the County's portion of employees' paid retirement offset and increases salary to mitigate the effect of the offset reductions by labor group beginning June 9, 2017;
- 2. Increases eligible employees' flex credits in January 2016, January 2017, and January 2018;
- 3. Increases salary by 2% in June 2015, June 2016, and June 2017:
- 4. Provides a one-time monetary payment equivalent to 1% of base pay effective June 23, 2017 and a one-time professional stipend of \$1000 for SDDCCA and PDA effective June 26, 2015;
- 5. Increases the Educational/Security and Educational/Professional stipends to \$2500 in 2015; and
- 6. Provides increases to employees' flexible core benefits.

Details of the tentative agreement are reflected in the background of this letter.

FISCAL IMPACT:

In Fiscal Year 2015/2016, today's recommendations are estimated to result in costs of \$3.57 million. The estimate includes ongoing base and supplemental pay net increases of \$3.04 million, flex credit increases of \$0.12 million, and one-time monetary payments of \$0.41 million.

Further, in Fiscal Year 2016/2017, today's recommendations are estimated to result in additional costs of \$2.66 million. The estimate includes further ongoing base and supplemental pay net increases of \$2.41 million, and flex credit increases of \$0.25 million.

Further in Fiscal Year 2017/2018, the costs associated with today's recommendations are estimated to result in additional costs of \$4.2 million. The estimate includes further ongoing base and supplemental pay net increases of \$2.75 million, additional flex credit increases of \$0.25 million, and one-time monetary payments of 1.2 million.

If approved, funding to support today's recommendations will be included in the CAO's Fiscal Year 2015-2017 Recommended Operational Plan. The funding source is a combination of General Purpose revenues, available General Fund fund balance, and various program revenues.
