



The Sustainable Land Use FRAMEWORK




WHAT IS THE SUSTAINABLE LAND USE FRAMEWORK?

The County of San Diego (County) Sustainable Land Use Framework (**Framework**) will be a guiding resource that will help inform and prioritize the County's direction on major policy and planning issues related to sustainable and equitable land use in the unincorporated areas. The Framework will provide a comprehensive and holistic approach to address housing, transportation, human health & equity, economic strength, climate, the natural environment, and hazards such as wildfire.

CURRENT STEP (STEP 3: APPROACHES & MECHANISMS)

Planning **Approaches** are identified to show the pathway for achieving the desired outcomes. The Approaches may include policy recommendations, regulatory changes, incentive programs, or community engagement initiatives. Planning **Mechanisms** are the tools or instruments through which the Approaches are implemented, such as zoning ordinances, development incentives, or infrastructure investments. Step 3 is expected to go before the Board of Supervisors in summer 2025.

The Goals (intended outcomes for key land use topics) and Objectives (broad methods or strategies to achieve these Goals) for the Framework (shown below) were developed by conducting research, engaging in public outreach (including virtual workshops, in-person events across the county, stakeholder meetings), and working across County departments.

The Focus Areas, Goals, and Objectives were received by the Board of Supervirors in September 2024. The next step for the Framework will be to develop Approaches and Mechanisms, and **we want you involved!**
