

#### San Diego's Prevention Definition



Prevention means families thrive in a connected community that enhances and restores nurturing and responsive relationships and environments. It involves aligning impact on multiple levels so that all *children* are safe and cherished, all *families* are nurtured to build up protective factors, and *systems/structures* create equitable pathways to wellness.

# Family First Prevention Services Act (FFPSA)

Shift toward prevention for child welfare

Prevent the need for families to ever make formal contact with the child welfare system

Prevent entry or re-entry into foster care

Provides opportunities for jurisdictions to create their own prevention pathway

Funding is available to agencies providing evidencebased programs (EBP) for eligible candidates







#### FAMILY STRENGTHENING FOCUS



Since 1998, San Diego Child Welfare has decreased the number of children in care by **64%** from almost 7,000 children to just over 2,300 through family strengthening efforts and enhanced engagement. The CFWB structural transformation will support families and communities in becoming stronger and resilient so that even fewer children will be negatively impacted by trauma experienced through systemic inequities.

FAYCES envisions a world in which individuals with lived experience within the system have ownership in how their lives are impacted.


Improving the experience of those impacted by the system by making them decision makers.
