 - i. 21-004 / Moreno (Death) SDSD
 - It is recommended that the San Diego Sheriff's Department (SDSD) identify who answers the "Arresting Officer Questions" on the Receiving Screening Questionnaire during the Booking process.

ii. 21-055 / Frost - SDSD

• It is recommended that the SDSD revise Patrol Procedures Manual Policy 25 Prisoner Transportation (and any other associated policies), as it pertains to Subsection C, Deputy's Responsibilities at Detention Facility to mandate that an arrestee *shall* be taken to a facility that coincides with the arrestee's gender identity. As such, an arrestee who identifies as being female *shall* be taken to Las Colinas Detention Re-Entry Facility or Vista Detention Facility, and an arrestee who identifies as being male *shall* be taken to San Diego Central Jail, or Vista Detention Facility. If the arrestee identifies as non-binary, the arresting officer *shall* inquire as to whether the arrestee would prefer to be booked into a male or female facility and transport accordingly.

iii. 21-060 / Meadows - SDSD

It is recommended that the San Diego Sheriff's Department (SDSD) create a policy that mandates
conducting all Detentions Investigative Unit (DIU) interviews in a private area, out of view from other
inmates.

iv. 21-096 / Cernilia - SDSD

 It is recommended that the San Diego Sheriff's Department (SDSD) expand Policy and Procedures Section 6.131 entitled, "Body Worn Camera (BWC)" to incorporate the use of BWC to record all law enforcement-related contacts/interactions (i.e., telephonic calls for service, deputy call-backs, etc.), not just those contacts arising out of in-person scene responses or in-person deputy-initiated contacts.

v. 21-100 / Richardson - SDSD

- This is the third incident over the past two years in which CLERB received complaints alleging that deputies assigned to the Imperial Beach Substation either failed to respond to community members while being videorecorded or attempted to interfere with a community member's right to videorecord law enforcement activity. In CLERB Case #20-025, there was insufficient evidence to determine whether, during nighttime hours, a deputy shined a flashlight toward the complainant for the purpose of interfering with his recording of the deputy's activities. In CLERB #21-024, CLERB sustained findings of a deputy refusing to acknowledge a complainant and provide identification upon request while being videorecorded. During that time, CLERB did not receive similar allegations about deputies assigned to any other station. As such, CLERB makes the following recommendation:
 - The SDSD update the Legal Affairs Update entitled "The Public Can Record the Police" dated 11-14-14, and document its review with all deputies, specifically those assigned to the Imperial Beach Substation.

vi. 22-058 / Blue - SDSD

• It is recommended that the SDSD create a Training Bulletin on the subject of handicap parking law enforcement, to include but not limited to temporary and permanent handicap placards and parking restrictions, for distribution to all patrol deputies.

- vii. Digital Scanning and Delivery of Non-Legal Mail to Incarcerated Persons SDSD
 - Digitally scan all non-legal mail and ideally deliver to the incarcerated person addressed the mail via an electronic and non-physical method, e.g., kiosk, computer terminal, etc.
- viii. Physical Search or Scanning of All Persons in Detention Facilities, to Include Staff SDSD
 - Physically search or body scan all persons entering a SDSD-operated detention facility, to include all SDSD employees, County employees, contractors, and those persons conducting countyrelated business. "All persons" also includes social and professional visitors and incarcerated persons (I/Ps) upon booking and transferring between facilities or re-entering a facility after having departed it for court, medical treatment, etc.
- ix. CLERB Staff Response to Death Scenes Probation
 - Allow a CLERB staff member with extensive death investigation experience to be present at the
 initial death scene and any related incident scene and, without compromising or obstructing the law
 enforcement investigation, receive a briefing, participate in a scene walk-thru, and have any
 questions about the circumstances surrounding the events leading up to, and including the death,
 answered.
- x. Use of Technology to Monitor Health and Safety of Inmates Probation
 - Research, and publicly report the results of its research efforts, i.e., associated costs, technology considered, reasons for not implementing, if applicable, etc., the use of technological devices to identify and subsequently aid inmates who may be in medical distress.

CASES FOR SUMMARY HEARING (10)

21-083/PARK

 Misconduct/Procedure – Numerous unidentified deputies denied Incarcerated Person Park food and water during her incarceration.

POLICY RECOMMENDATIONS

- It is recommended that deputies be required to notate in the Jail Information Management System (JIMS)
 each meal distribution in each housing unit, in conformance with California Title 15 Minimum Standards for
 Local Detention Facilities. If an incarcerated person misses a regularly scheduled facility meal and they are
 provided with a substitute meal and beverage, it will be notated in JIMS.
- 2. It is recommended that the completion or incompletion (and reason for incompletion) of all California Title 15 Minimum Standards for Local Detention Facilities requirements shall be noted in JIMS (showers, mail, etc.).

21-105/LENARZ

- 1. False Arrest Deputy 1 arrested Lenarz on 01-28-21.
- 2. Misconduct/Procedure Deputy 2 failed to interview Lenarz and/or conduct an investigation.
- 3. Misconduct/Procedure An unidentified deputy failed to take a crime report.
- 4. Misconduct/Procedure SDSD staff failed to provide a crime report to the complainant upon request.

21-107/BUCKELEW

- 1. Excessive Force Deputy 2 picked Buckelew up by his shirt, "threw" him in a wheelchair, and "excessively" chained him on 02-13-20.
- 2. Misconduct/Discourtesy Deputy 2 called Buckelew a "fucking piece of shit" on 02-13-20.
- 3. Misconduct/Discourtesy Deputy 3 "spit" on Buckelew on 06-07-21.
- Misconduct/Procedure Deputy 18 turned off the module phones on 06-17-21.
- 5. Misconduct/Procedure Deputies 4, 5, 6, 8, 11, 13, and 17 "violated" grievance procedures.
- 6. Misconduct/Procedure Deputy 10 "denied" Buckelew access to a telephone on 08-22-21.

- 7. Misconduct/Discourtesy Deputy 16 "antagonized, demeaned, disrespected, and/or was hostile" to Buckelew on 08-28-21.
- 8. Misconduct/Procedure Deputy 7 "refused" Buckelew access to his attorney on 09-13-21 and 09-14-21.

- 12. Misconduct/Procedure Deputies 1, 13, and 15 placed Buckelew in Administrative Segregation on 09-14-21.
- 13. Misconduct/Procedure Deputy 9 did not provide dayroom time to Buckelew on 09-24-21.

21-108/MORENO

- 1. Misconduct/Procedure Unidentified deputies failed to provide Moreno access to his counsel.
- 2. Misconduct/Procedure Unidentified SDSD staff did not accept and/or return Moreno's telephone calls.
- 3. Misconduct/Procedure Unidentified SDSD staff failed to assist Moreno with her complaint.
- 4. Misconduct/Procedure A SDSD Detentions Assistant, failed to identify employees who neglected to help/assist Moreno.

21-118/MONIGER (DEATH)

1. Death Investigation/In-Custody Medical – Robert Duane Moniger collapsed in his jail cell and despite lifesaving measures, he was pronounced deceased on 11-27-21.

21-126/GUERRERO

- 1. Use of Force Resulting in Great Bodily Injury Deputies 1, 2, 3, and 5 used force toward Pedro Guerrero while he was housed at the George Bailey Detention Facility (GBDF).
- 2. Use of Force Resulting in Great Bodily Injury Deputy 4 used force toward Pedro Guerrero while he was housed at the George Bailey Detention Facility (GBDF).

22-011/ROJAS

- 1. Use of Force Resulting in Great Bodily Injury Deputies 1-5 used force toward Omar Rojas while he was incarcerated at the Vista Detention Facility.
- 2. Misconduct/Procedure Deputy 6 opened two cell doors simultaneously.

22-028/ELWOOD

1. Use of Force Resulting in Great Bodily Injury – Deputies 1-8 used forced toward Nathan Elwood while he was incarcerated at the Vista Detention Facility.

22-036/ZHAO

- 1. Illegal Search & Seizure Deputies 1 and 2 evicted Zhao on 02-17-22.
- 2. Misconduct/Procedure Deputy 2 refused to accept legal documents from Zhao.
