Good afternoon, everyone,

As we discussed at last week's meeting, I want CLERB to always do what is legally permissible in this ever-changing world of civilian oversight and California law. As such, as discussed, we will start complying with PC 832.7, SB 16, and SB 1421 mandates by releasing deputy names in the situations listed in my email to the DSA below. As preparation for the June CLERB meeting is already underway, nothing will change for that meeting. **The below changes will take effect with the July meeting.**

Please take some time to become familiar with the categories listed below. They are exactly what we put forward in our R&R proposed revisions for extended time limitations for complaint filing.

Basic Overview and Plan:

In any investigation involving the discharge of a firearm at a person or the use of force resulting in GBI , as detailed in **Sections (A)(i) and (ii) below, no matter the finding**, we will release deputy or probation officer names in our Hearing Notices, Final Notices, Final Findings, and in the redacted on the agenda.

In the categories listed in **Sections (A)(iii) and (iv), (B), (C), (D), and (E)**, there must be **a sustained finding** for us to release deputy or probation officer names. So, in those situations, the redacted reports, Hearing Notices, and agendas will still list Deputy 1, PO 1, etc., as the actual finding is made by the CLERB. When CLERB makes a sustained finding for anything listed in those categories, we will then release the deputy or probation officer names in the Final Notices and Final Finding Reports.

Starting in July, we will also begin to list all applicable cases on a PC 832.7 link on our website, as well. This will include every case that meets the requirements listed below from the beginning of CLERB and that project will obviously take some time.

Thanks for your continued efforts to take CLERB to the next level of professionalism, timeliness, and relevancy all the while doing what we can to assist the SDSO and Probation to provide their best possible services.

Good morning, gentlemen,

I hope this email finds you both well. I wanted to let you know that I plan to start releasing deputy names for all disclosable categories under SB-16, 832.7, etc., just as the Department already does, for the following categories:

(A) A record relating to the report, investigation, or findings of any of the following:

(i) An incident involving the discharge of a firearm at a person by a peace officer or custodial officer.

(ii) An incident involving the use of force against a person by a peace officer or custodial officer that resulted in death or in great bodily injury.

(iii) A sustained finding involving a complaint that alleges unreasonable or excessive force.

(iv) A sustained finding that an officer failed to intervene against another officer using force that is clearly unreasonable or excessive.

(B) (i) Any record relating to an incident in which a sustained finding was made by any law enforcement agency or oversight agency that a peace officer or custodial officer engaged in sexual assault involving a member of the public.

(ii) As used in this subparagraph, "sexual assault" means the commission or attempted initiation of a sexual act with a member of the public by means of force, threat, coercion, extortion, offer of leniency or other official favor, or under the color of authority. For purposes of this definition, the propositioning for or commission of any sexual act while on duty is considered a sexual assault.

(iii) As used in this subparagraph, "member of the public" means any person not employed by the officer's employing agency and includes any participant in a cadet, explorer, or other youth program affiliated with the agency.

(C) Any record relating to an incident in which a sustained finding was made by any law enforcement agency or oversight agency involving dishonesty by a peace officer or custodial officer directly relating to the reporting, investigation, or prosecution of a crime, or directly relating to the reporting of, or investigation of misconduct by, another peace officer or custodial officer, including, but not limited to, any false statements, filing false reports, destruction, falsifying, or concealing of evidence, or perjury.

(D) Any record relating to an incident in which a sustained finding was made by any law enforcement agency or oversight agency that a peace officer or custodial officer engaged in conduct including, but not limited to, verbal statements, writings, online posts, recordings, and gestures, involving prejudice or discrimination against a person on the basis of race, religious creed, color, national origin, ancestry, physical disability, mental disability, medical condition, genetic information, marital status, sex, gender, gender identity, gender expression, age, sexual orientation, or military and veteran status.

(E) Any record relating to an incident in which a sustained finding was made by any law enforcement agency or oversight agency that the peace officer made an unlawful arrest or conducted an unlawful search.

Currently we identify deputies in those types of cases as Deputy 1, Deputy 2, etc., in all public releasable documents. For all deputy-involved-shootings, discharges of firearms, and uses of force resulting in great bodily injury cases, we will begin identifying them in our agendas and notices. When there are sustained findings in the other categories, we will identify the deputies in our Final Findings and Final Notices. We will also, in every case listed above, start posting the permissible parts of our report on our website, just as the Department does.

I would like to start doing this with the posting of our June agenda, which will occur on June 9. Do you folks have any concerns? Would you like to set a meeting to further discuss?
