Hello CLERB,

My name is Deidre McLeod and I am a constituent of Board Supervisor Joel Anderson, District 2; my pronouns are she/her. By not releasing all internal CIRB reports related to in-custody deaths by July 1 as required, Sheriff Martinez is committing a crime. We don't say that outright, though. Instead, she's "not complying with legal requirements" and "not providing the reporting required by law". But whatever the words, you cannot deny that the

person who is most supposed to uphold our laws is violating them.

CLERB has requested that the Sheriff release CIRB reports before. Tonight, I ask you to not only do so again, but to also 1) urge the Board of Supervisors to compel the Sheriff to comply immediately and 2) urge the Board to refuse to fund any legal challenge that would delay the release of these records for public inspection.
