

CLERB Thanks Sheriff for Policy Change in Response to Jail Search Recommendation

Over the past two years, the Citizens Law Enforcement Review Board, known as CLERB, has urged that all individuals entering San Diego Sheriff Department detention facilities be subject to body scans to prevent illegal drugs from entering to prevent overdoses and deaths. This policy recommendation was submitted twice to the department.

Today, the San Diego County Sheriff's Department announced a significant change to departmental policy that demonstrates agreement with CLERB's suggestion.

"CLERB has strongly urged the Sheriff to body scan every single person who works in our county jails to keep illegal drugs from getting inside. As CLERB's new chair, I thank Sheriff Martinez for hearing us and doing the hard work to build out and enact a plan to make every single person working in the jails subject to random, surprise contraband screenings. It will undoubtedly go a long way toward preventing overdoses, saving lives and sparing families the pain too many have suffered." said MaryAnne Pintar, CLERB's Chair.

"I also want to thank the families who show up every month to be a voice for their loved ones who have died in custody as well as the individuals who participate in our meetings consistently to advocate for change," she said.

CLERB was created by San Diego County voters in 1990 to provide independent investigation and oversight of the County's Sheriff's and Probation departments. Part of its authority includes oversight of all County jails in the unincorporated areas and in the nine cities that use the County's Sheriff's Department to provide law enforcement.

The Board's mission is "to increase public confidence in and accountability of peace officers employed by the Sheriff's Department or the Probation Department by conducting independent, thorough, timely, and impartial reviews of complaints of misconduct and deaths and other specified incidents arising out of or in connection with actions of peace officers."

CLERB meets publicly once a month in room 302 of the San Diego County Administration Center, located at 1600 Pacific Highway, San Diego, 92101.

SHERIFF KELLY A. MARTINEZ

A statement from Sheriff Kelly A. Martinez regarding a settlement involving the in-custody death of Elisa Serna:

Elisa Serna died in Sheriff's custody on November 11, 2019. Elisa Serna deserved better. My sympathy goes to the Serna family and everyone who has been affected by this case, and I am glad that the County of San Diego and the family have reached a settlement.

At the time of this incident, I was the Assistant Sheriff of Law Enforcement Services overseeing, among other areas, the Sheriff's Homicide Unit. It was brought to my attention that the detective assigned to investigate Elisa's death believed some of our own staff and contracted medical providers could be criminally liable in the case. I am grateful for the investigator's courage in bringing that information forward. We submitted the investigation to the District Attorney's Office for review and prosecution and the case ultimately went to trial earlier this year. I am grateful to the District Attorney, the court, and the jury for their careful consideration during the criminal trial.

When I was elected as Sheriff in November 2022, I attempted to meet with the Serna family, and they, perhaps understandably, did not respond to my efforts. I am glad that part of this settlement will provide me the opportunity to meet with them and I hope that meeting brings them further closure.

While the actions and decisions of a few individuals has been the focus of this case, our jail system has about 2,000 employees who provide for the safety and security of our jails. They see to the needs of the

incarcerated population, and work tirelessly behind the scenes providing tens of thousands of medical and mental health interactions for the more than 50,000 individuals processed through our jail system each

There have been <u>many changes</u> and an incredible shift in priorities, approach, and processes in our jails since 2019. As Sheriff I am committed to improving our jail system and ensuring the jails are safe for everyone who is incarcerated and for all our employees. I will continue to provide my staff with the training, tools, and equipment they need to do their jobs at the highest level.

Una declaración del alguacil Kelly A. Martínez con respecto a un acuerdo que involucra la muerte bajo custodia de Elisa Serna:

Elisa Serna murió bajo custodia del alguacil el 11 de noviembre de 2019. Elisa Serna se merecía algo mejor. Mis condolencias a la familia Serna y a todos los que se han visto afectados por este caso, y me alegro de el Condado de San Diego y la familia hayan llegado a un acuerdo.

En el momento de este incidente, yo era el Asistente del Sheriff de los Servicios de Aplicación de la Ley supervisando, entre otras áreas, la Unidad de Homicidios del Sheriff. Me llamó la atención que el detective asignado para investigat la muerte de Elisa creía que algunos de nuestros propios empleados y proveedores médicos contratados podrían ser penalmente responsables en el caso. Agradezco la valentía del investigador al presentar esa información. Presentamos la investigación a la Oficina del Fiscal de Distrito para su revisión y enjuiciamiento, y el caso finalmente fue a juicio a principios de este año. Agradezco al Fiscal de Distrito penal.

Cuando fui elegido como alguacil en noviembre de 2022, intenté reunirme con la familia Serna y, tal vez comprensiblemente, no respondieron a mis esfuerzos. Me alegro de que parte de este acuerdo me brinde la oportunidad de reunirme con ellos y espero que esa reunión les traiga un nuevo cierre.

Si bien las acciones y decisiones de algunas personas han sido el foco de este caso, nuestro sistema carcelario tiene alrededor de 2,000 empleados que se encargan de la seguridad de nuestras cárceles. Se proporcionando decenas de miles de interacciones médicas y de salud mental para las más de 50,000 personas procesadas a través de nuestro sistema carcelario cada año.

Ha habido <u>muchos cambios</u> y un cambio increíble en las prioridades, el enfoque y los procesos en nuestras cárceles desde 2019. Como alguacil, estoy comprometido a mejorar nuestro sistema carcelario y garantizar que las cárceles sean seguras para todos los encarcelados y para todos nuestros empleados. Continuaré brindando a mi personal la capacitación, las herramientas y el equipo que necesitan para hacer su trabajo al más alto nivel.
