Please see the amended Section 54953 of the Government Code, AB-2302 Open Meetings: local agencies: teleconferences:

(3) (A) The provisions of this subdivision shall not serve as a means for any member of a legislative body to participate in meetings of the legislative body solely by teleconference from a remote location for ~~a period of more than three consecutive months or 20 percent of the regular meetings for the local agency within a calendar year, or more than two meetings if the legislative body regularly meets fewer than 10 times per calendar year.~~ *more than the following number of meetings, as applicable:*

*(i) Two meetings per year, if the legislative body regularly meets once per month or less.*

*(ii) Five meetings per year, if the legislative body regularly meets twice per month.*

*(iii) Seven meetings per year, if the legislative body regularly meets three or more times per month.*

*(B) For the purpose of counting meetings attended by teleconference under this paragraph, a "meeting" shall be defined as any number of meetings of the legislative body of a local agency that begin on the same calendar day.*

Therefore, CLERB falls under section (3)(A)(i), **two meetings per year.**

For notification and training purposes, please read Section 54963:  
**54963.**

(a) A person may not disclose confidential information that has been acquired by being present in a closed session authorized by Section 54956.7, 54956.8, 54956.86, 54956.87, 54956.9, 54957, 54957.6, 54957.8, or 54957.10 to a person not entitled to receive it, unless the legislative body authorizes disclosure of that confidential information.

(b) For purposes of this section, "confidential information" means a communication made in a closed session that is specifically related to the basis for the legislative body of a local agency to meet lawfully in closed session under this chapter.

(c) Violation of this section may be addressed by the use of such remedies as are

currently available by law, including, but not limited to:

(1) Injunctive relief to prevent the disclosure of confidential information prohibited by this section.

(2) Disciplinary action against an employee who has willfully disclosed confidential information in violation of this section.

(3) Referral of a member of a legislative body who has willfully disclosed confidential information in violation of this section to the grandjury.

(d) Disciplinary action pursuant to paragraph (2) of subdivision (c) shall require that the employee in question has either received training as to the requirements of this section or otherwise has been given notice of the requirements of this section.

(e) A local agency may not take any action authorized by subdivision (c) against a person, nor shall it be deemed a violation of this section, for doing any of the following:

(1) Making a confidential inquiry or complaint to a district attorney or grand jury concerning a perceived violation of law, including disclosing facts to a district attorney or grand jury that are necessary to establish the illegality of an action taken by a legislative body of a local agency or the potential illegality of an action that has been the subject of deliberation at a closed session if that action were to be taken by a legislative body of a local agency.

(2) Expressing an opinion concerning the propriety or legality of actions taken by a legislative body of a local agency in closed session, including disclosure of the nature and extent of the illegal or potentially illegal action.

(3) Disclosing information acquired by being present in a closed session under this chapter that is not confidential information.

(f) Nothing in this section shall be construed to prohibit disclosures under the whistleblower statutes contained in Section 1102.5 of the Labor Code or Article 4.5 (commencing with Section 53296) of Chapter 2 of this code.

### Update: Death Investigation-Vista Detention Facility

*Victim identified.*

On December 28, 2024, around 9:00 a.m., Sheriff's Homicide investigators were notified 46-year-old Bobby Ray Patton, an individual in Sheriff's custody, passed away at the Vista Detention Facility. The San Diego Sheriff's Office extends our sympathies to Patton's family and those affected by his passing. A Sheriff's Family Liaison Officer will support the family as they deal with their loss.

On December 24, 2024, Mr. Patton told deputies he was having flu-like symptoms. He was seen by medical staff who ordered the appropriate tests. As a precaution, Mr. Patton was placed in medical isolation to ensure oversight of his symptoms and to prevent potential transmission to other incarcerated persons in custody.

On Saturday, December 28, 2024, around 8:00 a.m., while conducting their weekly hygiene inspection, deputies observed Mr. Patton sitting on the floor of his cell. Mr. Patton was breathing but did not respond to the deputies. Approximately 10 minutes later, two Medication Assistance Treatment deputies and a nurse contacted Mr. Patton in his cell. The nurse checked his vitals and offered him medication. While the nurse was talking Mr. Patton, he started having difficulty breathing and went into medical distress. Medical staff immediately provided emergency medical aid until relieved by Vista Fire Department personnel. Despite all efforts to save him, Mr. Patton succumbed and unfortunately passed away.

Mr. Patton was taken into custody on November 25, 2024, on a felony warrant for 4573.6 PC Bringing Controlled Substances into a Jail or Prison. At the time of his arrest, he was believed to reside in Escondido.

On December 30, 2024, The Medical Examiner's Office completed an autopsy of Mr. Patton. The Medical Examiner was unable to determine cause and manner of death during the initial autopsy.

Actualización: Investigación de muertes en el centro de detención de Vista

Víctima identificada

### **SINOPSIS DEL RESUMEN DEL INCIDENTE**

El 28 de diciembre de 2024, alrededor de las 9:00 a.m., los oficiales de homicidios del Alguacil fueron notificados de que Bobby Patton, de 46 años, un individuo bajo custodia del Alguacil, falleció en el Centro de Detención de Vista. La Oficina del Alguacil de San Diego extiende sus condolencias a la familia de Patton y a los afectados por su fallecimiento. Un oficial de enlace familiar del alguacil apoyará a la familia mientras lidian con su pérdida.

El 24 de diciembre de 2024, el Sr. Patton dijo a los oficiales que tenía síntomas similares a los de la gripe. Fue atendido por el personal médico que ordenó las pruebas correspondientes. Como medida de precaución, el Sr. Patton fue puesto en aislamiento médico para garantizar la supervisión de sus síntomas y evitar una posible transmisión a otras personas encarceladas bajo custodia.

El sábado 28 de diciembre de 2024, alrededor de las 8:00 a.m., mientras realizaban su inspección semanal de higiene, los oficiales observaron al Sr. Patton sentado en el piso de su celda. El Sr. Patton respiraba, pero no respondió a los oficiales. Aproximadamente 10 minutos después, dos oficiales de Tratamiento de Asistencia con Medicamentos y una enfermera se comunicaron con el Sr. Patton en su celda. La enfermera revisó sus signos vitales y le ofreció medicamentos. Mientras la enfermera hablaba con el Sr. Patton, él comenzó a tener dificultades para respirar y entró en angustia médica. El personal médico brindó asistencia médica de emergencia de inmediato hasta que fue relevado por el personal del Departamento de Bomberos de Vista. A pesar de todos los esfuerzos por salvarlo, el Sr. Patton sucumbió y lamentablemente falleció.

Sr. Patton fue detenido el 25 de noviembre de 2024 con una orden de arresto por delito grave por 4573.6 PC Traer sustancias controladas a una cárcel o prisión. En el momento de su arresto, se creía que residía en Escondido.

El 30 de diciembre de 2024, la Oficina del Médico Forense completó la autopsia del Sr. Patton. El médico forense no pudo determinar la causa y la forma de la muerte durante la autopsia inicial.
