**ACTION ITEM:** The Environmental Health and Quality Advisory Board (EHQAB) took unanimous action to send a letter to the Board of Supervisors to convey their support to authorize the continuation of the MEHKO program for the entire San Diego region. In addition, the EHQAB discussed policy considerations for the County of San Diego Board of Supervisors.
