


Need for Proposal

Septic Program Current Proposal

Need: FY 2025-26 costs require 11.8% average fee increase



Mitigation: Innovation average 2.7% reduction



Proposal: 9.1% average fee increase

Discretionary Projects Current Proposal

Need: FY 2025-26 costs require 9.4% average fee increase



Mitigation: Innovation average 2.7% reduction



Proposal: 6.7% average fee increase


