Mr. Cameron Humphres discussed asphalt repairs to be scheduled at Fallbrook Airpark.

AIRPORT MANAGER'S REPORT (Meadow Chase)

Under security items, Ms. Meadow Chase reported all gate codes had been updated at Fallbrook Airpark in response to growing safety and security concerns involving unauthorized individuals gaining access to Fallbrook Airpark and related facilities and properties.

Under maintenance items, Ms. Chase reported routine maintenance tasks such as sweeping, weed abatement, and asphalt repairs had been conducted at Fallbrook Airpark. Ms. Chase also stated mowing was to take place at an undetermined date in the near future at Fallbrook Airpark.

Ms. Chase presented a historical graph depicting the monthly operations counts at Fallbrook Airpark for 2021 and four years prior. She reported the operations counts as 2,108 in January 2021, 2,442 in February 2021, 2,994 in March 2021, and 2,328 in April 2021.

NEW BUSINESS


The FAAC discussed the status of conducting virtual and in-person meetings.
