## **AIRPORT MANAGER'S REPORT (Meadow Chase)**

Ms. Anne Baldwin announced that Mr. Jamie Abbott had been selected as the new Director of Airports of the County of San Diego, with a start date of August 26, 2022.

Under security items, Ms. Meadow Chase reported recurring issues of littering and vandalism in the Viewing Area of Fallbrook Airpark.

Under maintenance items, Ms. Chase reported that asphalt repairs, erosion control, and mowing and other weed abatement measures had taken place at Fallbrook Airpark.

Ms. Chase presented a historical graph depicting the monthly operations counts at Fallbrook Airpark for 2022 and four years prior. She reported the operations counts as 2418 in May 2022, 2268 in June 2022, and 2122 in July 2022.

Ms. Chase and Ms. Baldwin discussed the results of biennial leasehold compliance inspections conducted at Fallbrook Airpark. Mr. David Duffer requested a follow up at the next regular meeting with additional details on the corrective actions taken or being taken following the biennial leasehold compliance inspections conducted at Fallbrook Airpark.
