Quarry Road at Low Water Crossing

The project is located at the low water crossing at Spring Valley Creek where it frequently floods.

Project Purpose and Need

Flooding:

- Causes road closures
- Prevents access to residences and business
- Prevents emergency vehicles from accessing area

What improvement options were considered?

What Were the Improvement Options?

County Developed 3 Options:

- **Concept A:** Build new elevated bridge to eliminate all road closures due to flooding – realign road to remove sharp curve
- **Concept B:** Drainage improvements to reduce road closures due to flooding – maintains current road alignment
- **Concept C:** Improvements to existing gates – maintains current road alignment

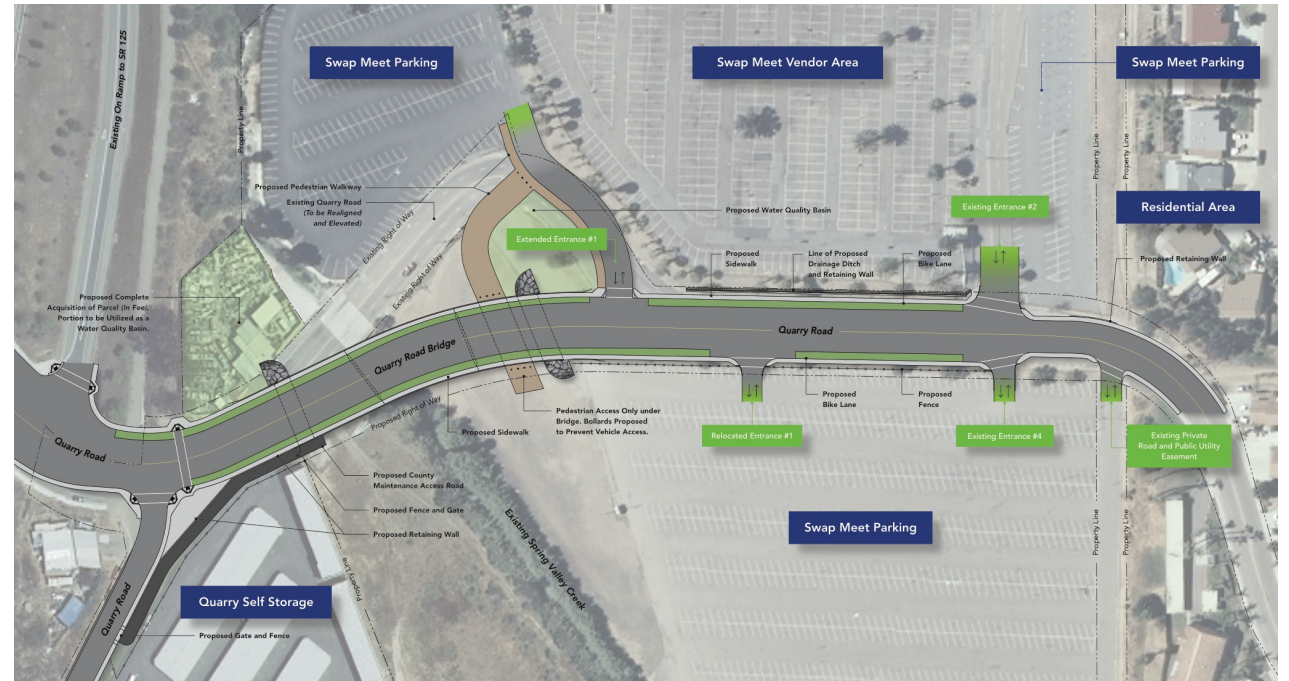

This Proposed Project Would:

- Construct a bridge on a realigned roadway that would be open in all-weather conditions
- Improve sidewalks
- Add new Class II bicycle lanes

- A Categorical Exclusion per the National Environmental Policy Act (NEPA).

Existing: 4 access points

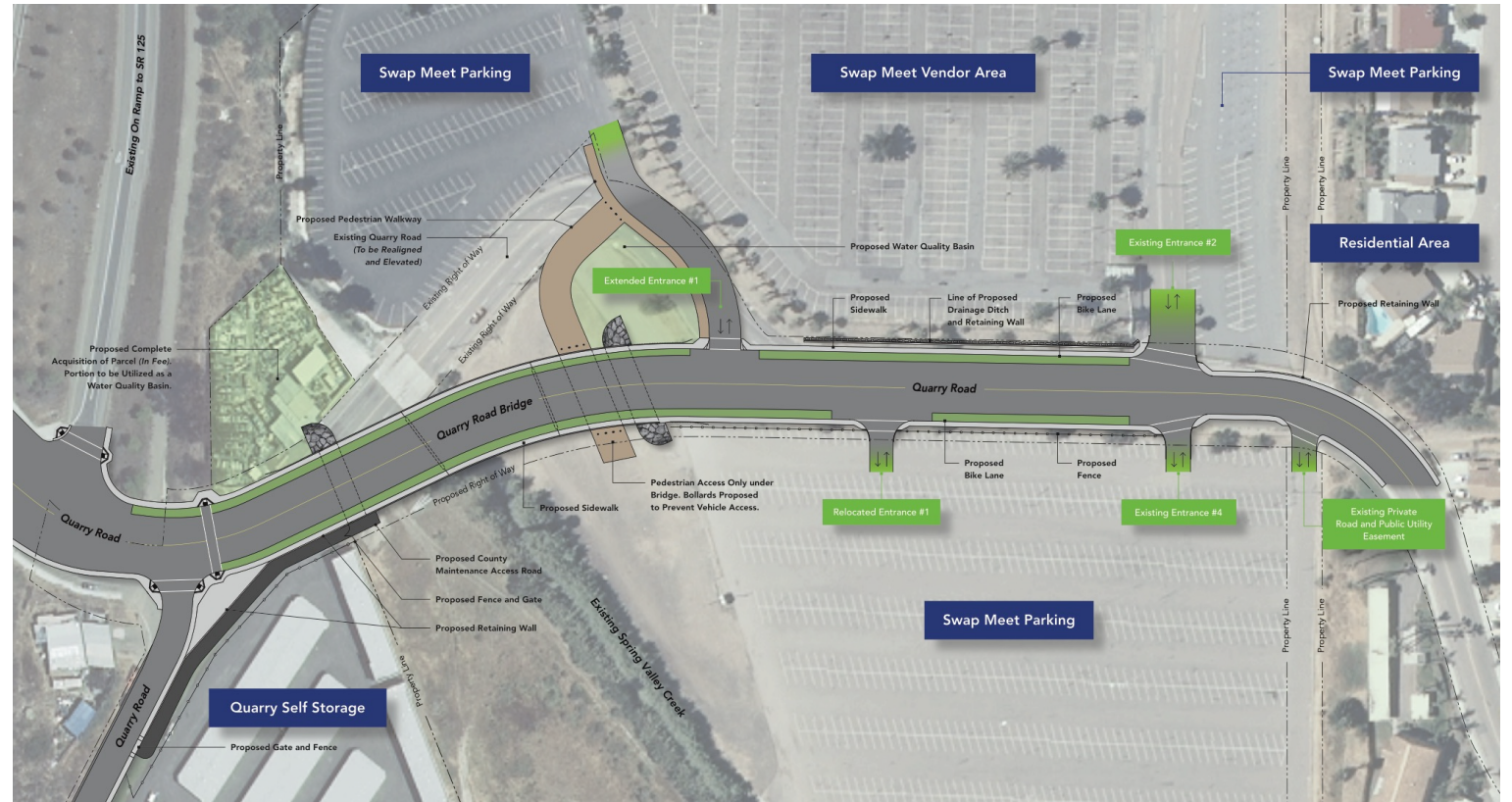
Future: 4 access points maintained
