- 4. Staff Reports
 - City of San Diego:
 - The City is holding the annual Christmas Tree Recycling Program and reported increased participation.
 - The City continues to plan for upcoming SB 1383 requirements.
 - The annual Curbsider publication was disseminated to residents in December.
 - The City is planning for a new multifamily complex recycling project to conduct door-to-door outreach at 15 complexes, distribute educational materials in multiple languages and recycling tote bags, and measure effectiveness with waste studies. Updates will be shared once they become available.
 - City of Encinitas
 - The City continues to plan for their upcoming organics recycling program.
 - The City is sponsoring virtual webinars with Solana Center and I Love a Clean San Diego.
 - Upcoming events include Conscious Closets Webinar (2/6/21) and a Virtual Zero Waste Fair (6/12/21).
 - City of Escondido
 - $\circ~$ Escondido Disposal Inc. will start their residential organics collection program in February.
 - The Escondido HHW facility remains open.
 - County of San Diego
 - The County continues to hold virtual webinars with I Love a Clean San Diego.

- The County is presenting proposed updates to the Non-Exclusive Franchise Agreement and Solid Waste Ordinance to the Board of Supervisors on March 17th.
- Scalvage
