Meeting Summary

1. QUORUM

The Chair determined that quorum was met and called the meeting to order.

2. WELCOME AND INTRODUCTIONS

Jurisdiction representatives and guests introduced themselves.

3. REVIEW OF THE APRIL 1, 2021 MEETING SUMMARY

Colleen Foster, City of Oceanside motioned to approve the April 1, 2021 Meeting Summary. Rimga Viskanta, City of Solana Beach seconded. <u>Motion carried</u> to approve the Meeting Summary.

4. PUBLIC COMMENTS AND COMMUNICATIONS

Mallika Sen, Solana Center for Environmental Innovation: The Solana Center in partnership with the County of San Diego is hosting a series of composting workshops and technical

assistance for unincorporated area residents. Solana Center in partnership with the City of Encinitas, and EDCO will be hosting farmers markets. For a full list of upcoming events visit the Solana Center website or contact Mallika Sen at Mallika.Sen@solanacenter.org.

5. CHAIRPERSON'S REPORT

Michael Wonsidler, County of San Diego: The County of San Diego Board of Supervisors unanimously approved proposed updates to the Solid Waste Ordinance and Non-Exclusive Franchise Agreement. Other approved sustainability items include native plants policy, structuring of sustainability programs, and development of sustainability plans for each County department.

6. CPSC UPDATE

Caitlin Lelles on behalf of Doug Kobold, California Product Stewardship Council (CPSC): CPSC's legislative report will be shared with attendees via email.

Attendees discussed **SB 619**, Organic waste: reduction regulations. Amended on April 13 and passed out of Environmental Quality.

7. PRESENTATION

Geertje Grootenhuis, San Diego Food System Alliance: The San Diego Food System Alliance concluded the Eco-Challenge program which challenged individuals and households to minimize food waste. The challenge included a robust consumer education campaign focused on food waste prevention and 5 tracking periods of 7 days in a 15-month period. The challenge resulted in a 38% reduction in food waste observed from those that participated in the entire 15-month period, exceeding the goal of 10% food waste reduction! Of the outreach materials delivered to participants, meal planning and smart grocery shopping tips were the most popular resources on their eco-challenge website following by proper food storage. SDFSA also shared that they launched their new and improved *Save the Food*, *San Diego!* Champions Toolkit which includes a monthly newsletter, social media graphics, and tips for reducing food waste.

An overview of the food recovery landscape in San Diego County was shared. Up to 1 in 3 people in San Diego County experienced food insecurity since the onset of the COVID-19 pandemic which was 1 in 7 people prior to the pandemic. 56% of individuals get food through federal assistance programs while 9% get food through private charities. NRDC reports that increasing food rescue for private charities could meet 25-50% of city meal gaps which is important because eligibility is typically more streamlined for these organizations. 8. CALRECYCLE UPDATE

Roberta Goldenpenny, CalRecycle: reported on the following:

- Best management practices for identifying tier 1 and 2 generators commercial edible food generators were released.
- SB 1383 formal rulemaking comments and responses have been posted to their website.
- The procurement calculator tool and webinar are available. This is an optional tool to
 assist jurisdictions plan for their procurement of recovered organic waste products and is
 not a recordkeeping document.
- Additional tools that are anticipated to be released in late 2021 include: survey tool for food recovery capacity, implementation record tool, organic waste recycling capacity planning tool and guidance, and route review best management practices. The community based social marketing plan is also anticipated to be shared late 2021. Updates will be shared as they become available.
- An update on <u>grant/loan cycles</u> was shared: Household Hazardous Waste Construction Grant (due 5/6), Household Hazardous Waste Small Projects Grant (due 5/6), Tire-Derived Product Grant Program (6/1).

9. COVID-19 GENERAL DISCUSION – No update.

10. SB 1383 & AB 1826- ROLLOUT ROUNDTABLE

IWMTAC Members: Members discussed collaborating on SB 1383 regional messaging and accessibility issues regarding different languages.

Jeanne Patton, City of San Diego: The City of San Diego Recycling Ordinance was updated on April 1. The City held a series of webinars for restaurants, wholesale food vendors and distributors, supermarkets, hotels, landscapers, multi-family complexes and janitorial sector on the Ordinance update as well as AB 1826 and SB 1383.

Michael Wonsidler, County of San Diego: The County is discussing eligible purchases of compost and mulch and enforcement mechanisms for organics procurement.

Colleen Foster, City of Oceanside: Colleen noted the role of gleaners in food recovery under SB 1383 requirements.

11. TARP YOUR LOAD/LITTER ABATEMENT – OPPORTUNITIES TO UNIFY OUTREACH

Michael Wonsidler, County of San Diego: The San Diego Regional Litter Abatement Subcommittee meets bi-monthly with the next meeting scheduled for Monday, May 10 at 1pm.

Risa Barron, Republic Services: The group will be meeting with haulers and CalTrans to discuss opportunities for public education.

12. SUBCOMITTEES' REPORT

a. Household Hazardous Waste - No report.

- b. Organics The group is presenting to the SANDAG Regional Planning Committee on June 4 regarding compost and mulch best management practices and expanding end product use. Interest in scheduling a demonstration site visit following the meeting to engage elected officials on the topic. USCC is hosting a composting training with tours of local facilities (June 8-10).

13. ROUNDTABLE

Manuel Medrano, City of Chula Vista: Per CA Fire code section 304.3.3 trash bins are required to be a certain distance away from buildings. While enforcing the code, the City received concerns from property owners/managers regarding adding additional bins.

Michael Wonsidler, County of San Diego: The County has created a series of short videos on various topics including encouraging <u>Reuse, Repair & Donation Before Recycling</u>; <u>Recycling Right; Reducing Food Waste at Home</u>; and <u>Composting.</u>
