7. CALRECYCLE UPDATE

Haley Aumiller, CalRecycle – Haley reported on the following:

- The SB 1383 Initial Jurisdiction Report is due April 1, 2022. CalRecycle developed an Initial Jurisdiction Compliance Reporting Tool available on the Model Reporting Tools [webpage](#).
- CalRecycle hosted a webinar on SB 1383 jurisdiction reporting tools for 2022 on February 17. The webinar recording will be posted to the website once it is made ADA compliant.
 - **Colleen Foster, City of Oceanside** requested information on the various reporting timeframes.
- CalRecycle has published a new informational [webpage](#) dedicated to SB 1383 requirements for reporting.
- CalRecycle has updated the SB 1383 [webpage](#) for procurement of recycled-content paper to include an optional recycled-content and recyclable paper certificate form.
- SB 619 applications were due March 1, 2022. Once applications have been approved, they will be posted on the NOIC [webpage](#).

- CalRecycle launched the [I Recycle Smart](#) education campaign and includes a variety of ads, website in English and Spanish, and tools that jurisdictions can use related to the campaign. A [webinar](#) regarding the campaign will be held on March 9.
- The next monthly public meeting is on March 15.

9. LEGISLATION

Ellyn Law, County of San Diego – Ellyn provided an update on the following bills:

- [AB 1985](#), Organic waste: list: available products– Introduced 2/10/22. Current law requires the State Air Resources Board to approve and implement a comprehensive short-lived climate pollutant reduction strategy and requires CalRecycle to in consultation with the board to adopt regulations and achieve organic waste reduction goals including a requirement intended to meet the goal that not less than 20% of edible food that is currently disposed of be recovered for human consumption by 2025. This bill would require CalRecycle to compile and maintain on its internet website a list, organized by zip code, of information regarding persons or entities that produce and have available in the state organic waste products and update the list every 6 months.
- [AB 2613](#), Farmers and ranchers: solid waste cleanup: grants – Introduced 2/18/22. Current law requires CalRecycle to establish a farm and ranch solid waste cleanup and abatement grant program for cleaning up and abating the effects of illegally disposed solid waste. This bill would require CalRecycle to establish a pilot project within the program, until January 1, 2028.

10. COVID-19 GENERAL DISCUSSION

Effective March 1, 2022, the County follows California Department of Public Health guidance that strongly recommends everyone wear a face covering in indoor public settings, whether you have been vaccinated or not.
