  - a. Solana Center Corporate offices at Walmart and Stater Bros. Markets have asked if monthly recordkeeping could be done at a corporate level rather than a per store basis. Roberta Goldenpenny from CalRecycle is currently looking into this.
    - i. Working with USDA and food banks to clear up corporate misconceptions regarding what is permitted with expiration dates.
    - ii. Ongoing issue with one Albertson's that believes they cannot donate food that was prepared/packaged inhouse, working with food banks and Vanessa Mello at DEHO.
  - b. County of San Diego Added corporate contacts to Regional Guidance Document.
  - c. City of Chula Vista Is there a corporate contact for Aldi?
    - i. Feeding San Diego Yes, can be provided upon request.

#### 3. SB 1383 - Rollout roundtable

a. Tier 1 & 2 – Questions & Discussion about grey area criteria

- i. SB 1383 v USDA requirements?
  - 1. County received info from the generator and CalRecycle is working with USDA and CDFA to clarify.
    - a. County of San Diego Still waiting on CalRecycle's decision, no recent updates.

#### b. Food Recovery Organization Site Visits

- 1. County of San Diego Updated commercial site visit checklist to include FRO questions that aren't compliance questions but still good to ask to better understand capacity and where food is being recovered (i.e., How much food did you rescue last year or are you able to rescue more?). Distributed with the minutes.
- c. Recordkeeping & Reporting (FRO's and Generators)
  - i. First reports due on Jan 31 (County and City of SD)
    - 1. County of San Diego County currently has no plans to create a template for FRO reporting.
    - 2. City of San Diego Polina Osipova is working on a template. Told Imperial Valley Resource Management Agency that they are willing to share FRO template with other jurisdictions when complete.

#### d. Other roadblocks, concerns for discussion

- Solana Center Despite sending organics back to warehouses or using them for animal feed, some businesses are still not collecting all organics. Informed that items that cannot be used for animal feed are landfilled.
  - 1. Ekolojik Inspecting dumpsters is crucial to finding foods that seemingly robust programs aren't accepting and landfilling.
  - 2. County of San Diego Many businesses have compactors that don't allow you to see inside, might need to get more creative and ask the staff.
    - a. Ekolojik Contrasting answers from staff members, shows opportunity for staff training and getting them internally on the same page,
