 - e. Oceanside: How does population growth affect food recovery? Wouldn't it be more correlated to business/economic activity?

 - a. County food distribution businesses that don't take physical custody. Per CalRecycle, should still be monitored as Tier 1 in case things change in the future.
 - b. Oceanside finding that farms are listed as food distributors, what are other jurisdictions doing?
 - i. County farms themselves are not food distributors, but if they have other operations (ex: an onsite warehouse), they may be both a farm and food distributor.
 - ii. Ekolojik suggest using wholesaler/distributor license list, note that there is no size requirement for these entities.
 See list attached.
 - c. Solana Center
 - i. Events. It is difficult for them to donate safely (food temp requirements). From a capacity planning standpoint, what to do. Do not want to artificially inflate the numbers. Put zero?
 - County included figures from events in our planning tool. Some have unopened/unprepared or packaged food that can be donated.
 - ii. Schools since some school districts have schools in multiple jurisdictions. CalRecycle note that for planning purposes, the entire school district should be attributed to the jurisdiction where most of the schools are located. (Ex Poway USD would all go to Poway)
- d. Other roadblocks, concerns for discussion
- e. Recordkeeping & Reporting (FRO's and Generators)
 - a. Concerns from FRO's on recordkeeping requirements

- b. CalRecycle guidance ok for FRO's and jurisdictions to report a combined total of food recovered. Do not need to separate out only Tier 1 and 2 generators
- c. Sharing Tier 1 and 2 generators lists with food banks. Will help food banks continue to identify generators not donating, and will help to set them up to donate.
