- 2. SB 1383
 - a. General Updates
 - i. County of San Diego CalRecycle shared that future guidance for non-local entities (NLEs) is forthcoming.
 - Chula Vista confirming education, inspection, monitoring = responsibility of the local jurisdiction. Enforcement = CalRecycle. Except for private businesses operating on the NLE (like a grocery store or fast food restaurant).
 - a. CalRecycle confirmed but it should be a collaborative effort with CalRecycle, local jurisdiction, and NLE. Same for local education agencies.
 - b. Education and Outreach
 - i. Chula Vista saw City of SD on the news about composting pumpkins!
 - c. Facility Updates no updates.
 - d. Procurement
 - i. Chula Vista 130cy stock pile of compost for Parks to use as needed. Also 4 distributions per year at the Otay facility for the public and working with local golf course.
 - ii. County of San Diego at December RMDZ meeting, CalTrans will speak on compost and mulch use.
- 3. Market development of processed organics
 - a. Compost & mulch application
 - 1. Training
 - a. San Pasqual Valley Soils signed a contract with Filtrexx for compost socks (mesh) distribution. Good for stormwater BMPs. Some meshes are biodegradable, and others are polypropylene (best for high water flow).
 - b. AgriService has a blower truck, so they can fill the socks. But they do not sell the actual mesh.

- c. County of San Diego compost/mulch blower demonstration at San Pasqual Valley Soils in October. Creates a berm that is good for roadside stormwater BMPs. Smaller unit (not a truck) that can be towed.
