# a. General Updates

- Solana Center Hosting a three-part <u>food recovery inspection training</u> on Nov 6-8 for a statewide audience through a partnership with CRRA. A discount is available for CRRA members.
- ii. County of San Diego
  - 1. EDCO is in the process of establishing two equestrian manure routes in unincorporated areas with large numbers of horses. The County continues to promote streamlined permitting opportunities in the zoning ordinance to expand facilities to process manure and other organics.
  - San Diego County Office of Education has started a working group for school garden leaders. If your jurisdictions have school garden programming, consider attending future meetings (next meeting 11/5) to share resources and connect locally. More details at: <u>Science (k12oms.org)</u>

  - Identification of key depts. and contacts, estimated acreage, challenges and limitations, successes, equipment needs, opportunities, priority projects, ROI, etc.
    - 1. Natalie Levy UC Soil Health Advisor led the discussion and shared updates on her work on creating a survey.
