vii. Goodwill San Diego

- 1. Events
 - a. In partnership with EDCO and will include paper shredding, ewaste and usable goods (6/15 at Emmanuel Faith Church in Escondido).
 - b. Poway on 6/22 at the City of Poway yard.
- 2. Starting some pilot projects with collecting and recycling soft plastics with Trex.
- 3. Hired another sustainability team member focused on community events.

5. Public Comments and Communication

- a. Attendees discussed
 - i. City of Imperial Beach is now the most polluted beach in US.
 - ii. City of San Diego-
 - 1. Mattress and box spring recycling collection reached 10,000 units per year (Mattress Recycling Council trailer is being swapped 3x/week).
 - 2. Collecting data on three different streams (illegally dumped, recycled, landfilled).
 - Between 9,000 to 19,000 mattress and box springs are still going to the landfill (fee booth is not turning around loads with mattress to recycle them).
 - 4. Updates on the Organic Processing Facility and insights into the possibility of a Resource Recovery Park will be shared at the next meeting.
 - 5. Measure B study is expected to be completed in 2025 with potential 2026 implementation.

iii. Ron Kagan

1. CBS 8 featured Planet Flip mobile app. He is also teaching a course at UCSD in engineering while tying in recycling-related topics.

iv. Zero Waste International Alliance

1. The Youth Convergence will likely be in San Diego within next 2 years (those under the age of 30). Could/would universities want to be involved?

6. Regional Planning issues

- a. Wasting Fee discussion (from Chair)
 - i. Has settled on a \$1 fee per ton of waste landfilled, which would generate \$3.5 million per year for recycling and toxic reduction education.
 - ii. Is currently looking for a Supervisor to back the proposal. May consider going directly to the Board of Supervisors and asking for support.
 - iii. A 4-page paper on the proposed "Waste and Toxic Reduction Disposal Fee" was shared with Supervisor Lawson-Remer's office as well as local non-profits.

- iv. An article on fee proposal will be in the High Sierran in July/August.
- 7. Legislative update
 - a. AB 2 Ward Recycling: solar photovoltaic modules

Solar panel EPR. On or before October 1, 2026, and on or before October 1 each year thereafter, CalRecycle to establish a covered solar PV recycling fee based on the reasonable regulatory costs to administer covered electronic waste recycling.

Now a 2-Year bill. Sitting in Senate Appropriations Committee as of 09/01/23.

b. SB 560 – Laird – Solid waste: gas cylinders: stewardship program

Gas cylinder EPR. This bill would establish a stewardship program for gas cylinder products and would authorize producers of those products to establish one more producer stewardship organization for that purpose.

Dead bill as of 1/18/24.

c. SB 707 - Responsible Textile Recovery Act of 2023

Textiles EPR. This bill would enact the Responsible Textile Recovery Act of 2023, which would require producers, as defined, either individually or through the creation of one or more stewardship organizations, to establish a stewardship program for the collection and recycling of covered textiles.

Amended 6/10/24; in Assembly Natural Resources Committee.

- d. AB 234 Bauer-Kahan Microparticles (dead bill as of 1/31/24)
- e. <u>AB 347 Ting Household product safety: toxic substances</u> (ordered to inactive file, 9/11/23)
- f. AB 660 Irwin Food labeling: quality dates, safety dates, and sell by dates (Amended and in Senate Ag. Committee as of 6/6/24)
- g. <u>AB 1290 Luz Rivas Product safety: plastic packaging: substances</u> Banning colored PETE (#1) bottles. (Dead bill as of 2/1/24)
- h. AB 1347 Ting Solid waste: paper waste: proofs of purchase "Skip the Slip."

Now a 2-Year bill. Sitting in Senate Appropriations Committee as of 09/01/23.

i. <u>AB 1659 – Gabriel – Sale of small electronic devices: charging devices</u> Universal small electronics receptacle.

Now a 2-Year bill. Sitting in Senate Appropriations Committee as of 09/01/23

j. SB 54 regulations have been released- <a href="https://calrecycle.ca.gov/packaging/packaging-

h. SB 1053 -- Solid waste: reusable grocery bags: standards: plastic film prohibition

This bill would revise the single-use carryout bag exception to include a bag used solely to contain or wrap specified uncooked foods and other specified items to avoid contamination, prevent damage from moisture, or for sanitary, public health, or environmental protection purposes. The bill would revise the definition of "recycled paper bag" to require it be made from 100 percent postconsumer recycled materials, without exception.

Passed the Senate on 5/21/24. Referred to Assembly Committee on Natural Resources.

i. SB 1143 -- Household hazardous waste: producer responsibility

This bill would create a producer responsibility program for products containing household hazardous waste and require a producer responsibility organization (PRO) to provide a free and convenient collection and management system for covered products.

Passed the Senate on 5/21/24. Referred to Assembly Committee on Natural Resources.

j. SB 1280 -- Waste management: propane cylinders: reusable or refillable

This bill would, on and after an unspecified date, prohibit the sale or offer for sale of propane cylinders other than those propane cylinders that are reusable or refillable, by 1/1/28.

Passed the Senate on 5/21/24. Referred to Assembly Committee on Natural Resources.

k. AB 2762 -- Plastic waste: California Reusable Beverage Container Act

This bill would require, for certain beverage manufacturers, by January 1, 2031, that no less than 5% of the volume of beverages that a beverage manufacturer sells in beverage containers in California be sold in reusable beverage containers, and that by January 1, 2032, no less than 60% of that 5% be in reusable beverage containers that were returned for reuse.

TBD hearing date in Appropriations Committee.

I. AB 2761 – Reducing Toxics in Packaging Act

This bill would enact the Reducing Toxics in Packaging Act, which would prohibit, beginning January 1, 2026, a person from manufacturing, selling, offering for sale, or distributing in the state plastic packaging that contains certain chemicals.

Passed Assembly on 5/22/24. Referred to Senate Committee on Environmental Quality to be heard 6/19/24.

8. Roundtable

- a. Federal Senate has approved a Recycling and a separate composting bill
 - i. S. 1194 Recycling and Composting Accountability Act Passed Senate on 3/12/24.
 - ii. <u>S. 1189 Recycling Infrastructure and Accessibility Act of 2024</u> Passed Senate on 3/12/24.
