#### SB 1383

### a. General Updates

- County of San Diego: Completed Compost and Mulch procurement contract.
  Other jurisdictions are invited to piggyback off it if desired and allowed by their charter. Questions: please contact Michael Wonsidler.
- ii. Solana Center: Getting interest in providing education outreach to schools. Confirmed that the state would take enforcement actions for SB 1383 for public educational institutions.
- iii. County of San Diego and San Pasqual Valley (SPV) Soils: Mike and Craig will be presenting at <u>CASQA</u> to educate members on SB 1383 procurement and compost and mulch best management practices for storm water pollution prevention
- iv. City of Chula Vista: They are partnering with Parks and the Open Space Department to conduct a mulch research study on golf course application.
- v. County of San Diego: Planning and Development Services is creating a pilot carbon farming incentive program through compost vouchers for farmers.

### b. Education and Outreach

- i. County of San Diego: will be hosting 6 compost and mulch giveaway sites for International Compost Awareness Week May 5-11.
- ii. SPV: Community Colleges are interested in getting in involved in compost education

- i. For SB 1383 procurement, we are required to track recycled paper products as well. Vendors, such as Office Depot and Staples, can provide reporting if needed and there may be options to limit purchasing.
- ii. City of Chula Vista: They leverage the software <a href="PaperCut Program">PaperCut Program</a> to help limit paper use. The software actively reminds users of their paper use and impacts and adds features to ensure staff only print needed materials (confirming need to print and requires badge access).
