3. Presentation: Organics Capacity Planning

a. **Stephanie Ewalt, County of San Diego Consultant:** Stephanie provided an overview of edible food recovery and organic waste disposal capacity planning requirements for jurisdictions. Jurisdictions are required to plan for the 10-year period of January 2025-Dec 2034. The County has developed an edible food

 - b. **SB 560,** Solid waste: gas cylinders: stewardship program. Look for a reintroduction of a new bill.
 - c. **SB 707,** Responsible Textile Recovery Act of 2023. CPSC sponsored.
 - d. **AB 863,** Carpet recycling: carpet stewardship organizations: fines: succession: training.
 - e. AB 1238, Hazardous waste: solar panels.
 - f. **AB 615,** Vehicle traction batteries.
