- ii. Around since 1992. Role to coordinate surplus food donation. Currently working with about 20k donor agencies.
- iii. Reports are sent monthly and annually, can assist with jurisdictional reporting.
- iv. Questions:
 - 1. North County Food Policy County How many San Diegan regional outlets are you now working with? What is the fee?
 - a. Food Donation Connection Would need to confirm the number. Fee charge is based on a percentage of donor's tax savings.
 - 2. Samantha Irwin For eLogs, do individual generators have access for record keeping purposes?
 - a. Food Donation Connection The eLog portal is always available to donors, as well as monthly and annual reports.
 - 3. Solana Center- Are you open to work with businesses who might not have consistent donations but more ad hoc donations?
 - Food Donation Connection Can assist if there's consistency on recipient and donor's sides. If donations are more ad hoc, FDC can make the introduction, but communication of pickups would be up to both agencies. Pickups are typically on a scheduled basis.
 - 4. North County Food Policy Council Do the services that Food Donation Connection provides to food generators satisfy the local jurisdiction requirements under SB 1383?
 - a. Overall, yes.
 - 5. Solana Center How do you guide food generators with donating prepared foods?
 - a. Food Donation Connection Food safety is our #1 priority, FDC works with food safety teams at donor sites to reinforce that:
 - i. No foods that have left the back-of-house can be donated.
 - ii. Foods are rapidly cooled through the danger zone, and ideally frozen prior to pick up.
 - iii. For generators that are unable to freeze food for donation, ensure cooling process and increase pickup frequency (every 2-3 days).
 - iv. ServSafe Food Handler's certification is a requirement for all staff.
 - City of Oceanside How are you involved in terms of recordkeeping? Would jurisdictions need to reach out to the Food Recovery Organizations (FROs) or FDC?
 - a. Food Donation Connection Records are provided monthly and should be kept in a binder onsite. FDC does not consolidate information for FROs, only donors. Trainings for FROs on obtaining records are available on their website.
 - 7. City of Oceanside Would a copy of an MOU satisfy the agreement requirement for SB 1383?
 - a. CalRecycle Yes, that would be a compliant contract.
 - 8. Solana Center Are there 2 different agreements for donors and FROs?

- a. Food Donation Connection Separate MOUs for donors and FROs. Agreements should be available onsite and on the portal.
- 9. Food Donation Connection Is there a capacity limitation for Food Donation Connection to have agreements with additional food generators?
 - a. Food Donation Connection No capacity restrictions.
 - Food Donation Connection Smaller donors may instead be coached on employee meals, repurposing their menus, food safety, and connecting them with a charity.
- 10. EcoTech Consulting Do you have example of smallest types of donors that you're currently working with?
 - a. Food Donation Connection Would need to follow up on this.
- 11. Jimbo's Are there particular types of containers that donors find is best for freezing? Are there expectations around the portion size of frozen foods to be donated?
 - a. Food Donation Connection FDC can provide clear food-safe donation bags with preprinted labels with food safety requirements and a space for donors to write down food type, date, quantity, and location.
 - b. Food Donation Connection Bags come in three sizes: 12x14, 15x17, and 23x24. Bags are generally not recommended for hot foods.
 - c. Food Donation Connection Cambro pans can also be provided and reused in restaurants.
- 12. EcoTech Consulting Are there any geographical limitations?
 - a. Food Donation Connection No, coast to coast, in 30 different countries
- 13. Annika Andersen Are the bags free of charge for donors?
 - a. Food Donation Connection Generally not. Consumable bags are 7-8 cents a pack plus shipping. Reusable Cambro pans are discounted.
- 14. EcoTech Consulting Who should consultants provide as a contact when in the field?

3. SB 1383 – Implementation, Discussion, Q&A

- a. Capacity Planning Reminder Due to County on May 16th, 2024.
 - 1. <u>County Tools, Trainings, and Presentation</u> (bottom of page)
 - Solana Center One of the sectors where there is a lot of variation is wholesale food vendors. How are we looking to input this information in the tool?
 - a. EcoTech Consulting Jurisdictions can either enter in a manual entry by calculating the average of both the high and low producers or provide more detailed calculations based on site visits if known.

- b. EcoTech Consulting In the tool, there is an area for estimating tonnages for schools, the number in the tool is more closely associated with a district rather than individual schools. Consider that number closely associated with a district. If you've visited a district and know the real numbers, this will whittle down the estimated tonnage.
- b. Tier 1 & 2 Questions & Discussion
 - 1. Past questions for CalRecycle: See <u>Regional Guidance Doc for Responses</u>
 - a. Solana Center Regarding malls, discussion on who the contact should be. Per CalRecycle, malls could fall under the definition of a large venue. Responsibility is with mall management to ensure appropriate vendors are participating and compliant. For best practices, inspections should be conducted with mall management present.
 - i. County of San Diego Would a plaza also fall under this guidance?
 - 1. CalRecycle Yes if the plaza falls under the definition of a large venue.
 - CalRecycle Onus is on venue operator to ensure all their vendors know the requirements and have venue operator at a plaza be aware contracts and recordkeeping.
 - 1. EcoTech Consulting Food banks requests that agreements are with the food facilities themselves, rather than with the plaza manger.
 - b. Solana Center If we come across a Tier 2 restaurant on the outskirts of a mall's property, should we inspect them individually or collectively under the mall's management.
 - i. CalRecycle Generators may fit multiple definitions, may be more beneficial to inspect them as a separate entity.
 - c. City of Carlsbad Observations from previous Tier 2 large venue site visits:
 - i. Some venue operators had larger agreements with the venue itself when they had better connections with their tenants.
 - ii. Other venues had individual agreements where there was more of a disconnect with tenants.
 - 2. President of Canyon Crest Sustainable Initiatives CCA Student conducting business outreach discuss.
 - a. EcoTech Consulting Cold calling businesses to help businesses (especially Tier 2s) navigate through SB 1383. Stephanie to provide a list of SB 1383 contacts per jurisdiction.
 - i. Solana Center Initial concern with information being accurate.
 - 1. EcoTech Consulting Shares this concern, will provide jurisdiction's information and guides.

- iii. CalRecycle Student reached out to CalRecycle regarding using the complaint portal.
 - 1. EcoTech Consulting Recommended that the student go through local jurisdictions first before going straight to complaint portal.
- iv. Solana Center For the cities that we are supporting, we are going to request that he syncs with us first as we want to ensure that businesses are not being overwhelmed.
- c. Site Visits/Inspections DEHQ Myths and Challenges
 - i. DEHQ Q&A
 - ii. DEHQ offer to host a webpage on County website for regional SB 1383 resources.
 - 1. County staff met with DEHQ to discuss layout and content.
 - 2. Ongoing request: All jurisdictions to add and/or update their resources on <u>Regional Guidance Document</u> under the tab Jurisdiction & DEH Contacts
- d. Food Recovery Organization Site Visits
 - i. Share feedback and response from recent site visits (group)
- e. Recordkeeping & Reporting (FRO's and Generators)
 - CalRecycle A local contract is not needed so long as local link is established through an existing contract. (I.e. A local contract would not be needed if an existing Feeding America contract had an addendum that included Feeding San Diego).
 - ii. Food Donation Connection Memorandums of Understanding can be multilevel with major food bank or smaller FROs, reporting is up to charity if they want the reporting to go through their partnership with the FBs or not.
 - 1. Solana Center Reporting should be submitted by local FROs to the jurisdiction that they are located in. Food banks would not be reporting on this.

- a. San Diego Regional Food Systems GIS Map
 - i. North County Food Policy Council Unable to enlist new interns for the spring semester. Fall semester interns currently working on mapping data for Coronado, Santee, and Chula Vista.

- i. Jurisdictions need to start understanding which FRO's and other orgs are best suited to accept prepared (Tier 2) foods.
- ii. Options besides donation (Too Good to Go, donating to employees, donating to local homeless)
 - 1. Tracking by generators will be key.

- d. Food donation videos (County led for regional use)i. SB 1383-specific and general food donation
