#### 2. Public Comments & Communications

- a. Open Comments
  - Solana Center Cities have been asking if other jurisdictions have received CalRecycle funding yet or if they have received any feedback from CalRecycle.
    - 1. EcoTech Consulting County of San Diego reached out for additional information, still pending an update.
    - 2. City of Coronado CalRecycle sent cities a request to update their budgets a month ago, assuming it will still be a couple more months.

- a. City of San Marcos Followed up with CalRecycle last week, no update. City sent their budget modification as well.
- 3. EcoTech Consulting The original timeline for when funding was to come out was March.
- 4. EcoTech Consulting Update from CalRecycle was received after meeting: "Invoices will be going to accounting in the next week or so and money will be distributed in the next couple of weeks."
- ii. Solana Center City of Imperial Beach inquired CalRecycle about using initial funding for electric bikes to be used for inspections.
  - 1. City of Imperial Beach CalRecycle denied request stating that the request was not considered part of their applicable criteria for funding.
- iii. ProduceGood We are hiring a Program Manager! Visit <a href="https://www.producegood.org/job-openings">https://www.producegood.org/job-openings</a> to learn more.
- iv. City of Chula Vista City of Chula Vista's annual South Bay Earth Day was held last Saturday, April 13<sup>th</sup>, with approximately 3,000 attendees. Provided reusable water bottles, metal straws, and mesh bags as prizes for participating in sorting activities.
  - 1. EcoTech Consulting Did the City give out any bags or liners for food waste bins.
    - a. City of Chula Vista Liners are typically reserved for businesses that have Chula Vista's food waste containers.
  - 2. ProduceGood These events/activities are essential for addressing "trash anxiety," City of Chula Vista's event/staff did a great job with informing attendees.
  - 3. City of San Diego Was food served at the event and was an edible food recovery program implemented during the event?
    - a. City of Chula Vista Yes, food was available during the event. Three bin (64-gal.) systems were implemented. Attendees were also informed that single-use plastic cutlery would not be allowed. Next year they will provide wooden utensils to swap out for single use ones.
  - 4. City of San Diego Did the City of Chula Vista consider the event as a tier 2 large event and did their vendors have edible food recovery agreements?
    - a. City of Chula Vista No, vendors did not have edible food recovery agreements in place. Vendors consisted of 2 food trucks and a shaved ice truck. Followed DEHQ's guidance on not recovering from food trucks.
- v. ProduceGood Attended a ReFED meeting where they showcased a 2022 report by the Pacific Coast Collaborative showcasing how different communities along the Pacific West Coast are making progress with food waste reduction; however, San Diego was not included in the report.
  - 1. Report to be included with minutes.

- 2. EcoTech Consulting Pacific Coast Collaborative reached out to the County a few years ago, but communications fell off the radar.
- vi. Solana Center Shoutout to both food banks for their assistance with capacity planning. Despite their huge workload, they have both been of great help for cities.

## 3. SB 1383 - Implementation, Discussion, Q&A

- a. Enforcement Plans/Process (Mallika)
  - a. Shared resources
  - b. Have any jurisdictions started enforcing?
    - Solana Center Where are other jurisdictions at with enforcement? Solana Center obtained an NOV template from Marin County. Inviting cities to share their enforcement processes and templates if available. Aware that the County of San Diego, Chula Vista, and Carlsbad already have defined enforcement procedures.
      - 1. Marin County NOV template to be included with minutes.
      - 2. EcoTech Consulting If there are any cities that want to make a NOV template, so that jurisdictions aren't recreating the wheel.
      - 3. City of Chula Vista Happy to share NOV template. Where should it be sent to?
        - a. EcoTech Consulting Should be emailed to <u>stephanie.ewalt1@sdcounty.ca.gov</u>, will compile and share templates out with the group.
    - ii. City of Chula Vista Main focus is on education; however, now that we can enforce, the mentioning of enforcement during visits tends to stir conversations more towards compliance.
      - 1. EcoTech Consulting Sometimes the warning is just enough.
    - iii. EcoTech Consulting Has working with Canyon Crest Sustainable Initiatives (Brian Guo and team) been helpful for jurisdictions?
      - City of San Diego Met with Brian and his student advisor. Initial concern with having students make classification/compliance calls, would like to continue working together but would also want to limit confusion for businesses.
      - 2. County of San Diego Brian spoke with County staff inquiring whether specific restaurants were on the County's radar. County staff informed him that they were on their list and that the County typically schedules visits in advance so to be mindful that each jurisdiction runs at a

different pace. Open communication with jurisdictions is essential to utilizing their resources.

- b. Capacity Planning Reminder Due to County on May 16<sup>th</sup>, 2024.
  - 1. County Tools, Trainings, and Presentation (bottom of page)
    - a. EcoTech Consulting Solana Center posed question to CalRecycle regarding how different methodologies are being used by jurisdictions for capacity planning.
      - i. Solana Center CalRecycle confirmed that the County's tool is correct in how it is being used and presented.
    - b. EcoTech Consulting Regarding wholesaler and distributor reporting, the number of pounds disposed appears to calculate high in the toolkit.
  - 2. SANDAG population projections added to regional sheet
- b. Tier 1 & 2 Questions & Discussion
  - Past questions for CalRecycle: See Regional Guidance Doc for Responses
    - a. City of Chula Vista Regarding Bayfront RV Park, originally believed to be a tier 2 hotel; however, CalRecycle provided guidance stating that RV parks would not be considered a tier 2 hotel.
  - 2. City of San Diego While working on capacity planning, City is having to revisit how businesses were classified the first time around. As such, the following questions were raised:
    - a. City of San Diego Waterfront Park is a county facility in the downtown area. For events hosted at this location, would they be considered city or county events? Concerned with double counting.
      - EcoTech Consulting If the event is set in an outdoor venue or permitted through the City of San Diego, then it would be considered a city event.
      - ii. EcoTech Consulting If an event is being held in a large brick and mortar venue (like a convention center), it should only be counted as either a large event or a large venue, but not both.
    - b. City of San Diego For the events at waterfront park, we don't enforce any waste regulations at that event, is that relevant?
      - i. County of San Diego The County of San Diego oversees all scheduling and coordination at

- Waterfront County Park; however, waste management is a mix of County and CAC oversight.
- ii. CalRecycle Situation could be treated like local entities where City of San Diego is responsible for education and outreach but not enforcement.
  - EcoTech Consulting Several jurisdictions have county facilities within their boundaries, would be good to connect on these topics.
- iii. CalRecycle Here are two of our guidance documents on identifying commercial edible food generators:
  - Guidance for Jurisdictions: How to Identify Commercial Edible Food Generators
  - Definitions for Commercial Edible Food Generators for Non-Local Entities and State Agencies
- c. City of San Diego Regarding events that cross though jurisdictional boundaries, such as a bike event that is permitted with the City of San Diego but ends with a festival in City of Coronado. In this case, would Coronado handle the festival side of the event?
  - i. EcoTech Consulting Situation may be more complex since the event is permitted with the City of San Diego.
  - ii. Solana Center Posed a similar question to CalRecycle regarding marathons.
    - CalRecycle If there are stops throughout the City of San Diego, they would need to be added to the City of San Diego's event list. If food, water, and snacks are being passed out, jurisdiction can use their owner discretion.
  - iii. City of Coronado Such events are not required to obtain a permit through the City of Coronado, so staff would be unaware.
    - Solana Center Communication amongst jurisdictions is key.
    - 2. EcoTech Consulting Event would be under the jurisdiction that it is permitted with, numbers can be adjusted accordingly.
- d. City of San Diego If a city is sponsoring, but not operating an event, then they would not be considered a tier 2 large event, correct?

- CalRecycle Guidance specifies that if an event is operated by a local agency, then it is considered tier 2, sponsoring an event would not be considered the same as operating one. Best to handle on an event-by-event basis.
  - CalRecycle Events with over 2,000 attendees that are either operated by a local agency or charge admission are consider tier 2.
- e. City of San Diego If a school is the location for a large event, would the tier 2 large event be separate from the tier 2 local education agency?
  - EcoTech Consulting If the school is just being used as the location, they may have to be separated out.
    - 1. Solana Center Echoing that the event and school should be viewed as separate tier 2s.
  - CalRecycle Jurisdictions can schedule calls with local CalRecycle staff to discuss logistics. Emily Schuetz is the local point of contact for San Diego. Email at Emily.Schuetz@CalRecycle.ca.gov.
- 3. Solana Center Do any jurisdictions know of businesses that are donating to local homeless? Businesses are extremely reluctant and would like to connect on a working model.
  - a. No comments.
- c. Site Visits/Inspections DEHQ Myths and Challenges
  - i. DEHQ Q&A
    - 1. No questions.
  - ii. DEHQ offer to host a webpage on County website for regional SB1383 resources
    - 1. County staff met with DEHQ to discuss layout and content
    - 2. Ongoing request: All jurisdictions to add and/or update their resources on
      - a. Regional Guidance Document under the tab Jurisdiction & DEH Contacts
- d. Food Recovery Organization Site Visits
  - i. Share feedback and response from recent site visits (group)
- e. Recordkeeping & Reporting (FRO's and Generators)
  - City of Chula Vista Gathering reports and capacity planning data from FROs requires repeated asks for information and a bit of handholding. Gleaning through information has also proved to be challenging.

- 1. EcoTech Consulting Do you have a template or other resources available for FROs and FRSs?
  - a. City of Chula Vista Not yet, but creating a template is on the docket.
- 2. County of San Diego Also important to take detailed notes on conversations with FROs to compare their verbalized practices with their reporting to ensure recovery outside of food bank agreements is not missed.
- ii. San Diego Food Bank Observed pushback from partnered nonprofits, emphasize open lines of communications and a reminder to jurisdictions that recordkeeping and reporting is not their purview.
  - 1. EcoTech Consulting Has there been any more thought regarding food banks providing data directly to jurisdictions?
    - a. Feeding San Diego No plans to change current reporting processes. Intention is for FROs/FRSs to own their data, allows them to include numbers that they are recovering outside of their agreements.
      - County of San Diego Does this mean that FROs/FRSs can add pounds recovered outside their agreements to MealConnect.
        - Feeding San Diego No, data can be exported and downloaded by FROs/FRSs, outside recovery can later be added to the report.
        - 2. Food Donation Connection FROs can pull pounds by generator for reporting. FDC also provides monthly trainings on how to acquire information for reporting.
- iii. Food Donation Connection Where do FROs report their poundage, is there a specific website or form that is used for reporting?
  - 1. EcoTech Consulting No uniform way, reports are typically received by email or other means.
- iv. Food Donation Connection Do FROs only need to report the names of each generator and pounds recovered per month?
  - 1. City of Chula Vista For annual reporting, name, address, and annual pounds recovered per generator is required.
  - 2. County of San Diego County also requires contact information for each generator.
  - 3. Solana Center Many cities also require food generators to provide annual reports.
    - a. Food Donation Connection We also supply our food generators with regular reports that contain all required information for compliance.

- f. Other roadblocks, concerns for discussion
  - San Diego Food Bank After onboarding discussions (including food safety and donation requirements) with potential partner agencies, some donors have expressed feeling forced to donate despite not having excess amounts of donatable food.
    - 1. EcoTech Consulting Are as needed agreements still recommended for restaurants. They appear to be a good solution but curious if it is just more busy work for the food banks.
      - a. San Diego Food Bank As needed agreements are standard, but the current increased volume is new. There are a lot of donors that are currently being onboarded using as needed agreements. Partnering with a FRO or food bank is commonly just a check box on their to do list.
    - 2. City of San Diego Hearing similar concerns from restaurants, recommend owners to seek an as-needed agreement especially for holidays and events.
    - 3. Solana Center Staff always open the conversation with food donation is not mandatory, if you don't have food to donate then you do not have to get into an agreement.
      - a. Solana Center Restaurants only have 9% of food waste that is potentially donatable.
  - ii. Solana Center Is tracking donations to staff more burdensome than helpful? Many have expressed that if it is not required by law, then they will not track donations to staff.
    - 1. EcoTech Consulting If they are donating to staff, still best to encourage keeping records for best practices.
    - 2. EcoTech Consulting For restaurants, good to focus on the organics recycling, especially if there is minimal excess donatable food.
  - iii. HF&H Consultants Different jurisdictions are taking different approaches based on generator type. Looking into having different types of inspection forms based on sector type.

#### 4. SB 1383 - Public Education Resources

- a. San Diego Regional Food Systems GIS Map
  - i. North County Food Policy County Developing public and non-public platforms to map SB 1383 data, including data from Tier 1s, Tier 2s, FROs, and FRSs. Potentially receiving another intern for the summer session.
- b. Resources for Tier 2 Public Education:
  - i. Jurisdictions need to start understanding which FRO's and other orgs are best suited to accept prepared (Tier 2) foods.
  - ii. Options besides donation (Too Good to Go, donating to employees, donating to local homeless)
    - 1. Tracking by generators will be key.

- iii. CalRecycle CalRecycle staff will follow up internally regarding creation of more Tier 2 documents.
- iv. CalRecycle Reminder of SB 1383 Chat with CalRecycle tomorrow, April 17<sup>th</sup>.
