5. STAFF/ AGENCY REPORTS

A. Administrative Report – Andy Parr

- 1. Andy Parr introduced the new EMS Medical Director Kristi Koenig, M.D.
- 2. Dr. Kristi Koenig introduced herself to the CSA17 Advisory Board. She is a Native Californian; in fact she lived and worked in Del Mar while earning her undergraduate degree at UCSD. She is looking forward to working with the Advisory Board and creating systems that are data driven.
- 3. Implementation of the Electronic Patient Care Record and Certifications system (ImageTrend) is on track to be compliant with the State regulations. The agencies are collecting demographic data such as TOC, Illness and injuries present, the most common kind of 911 calls. These are example of the type of data being collected. Plan to have an Epidemiologist come to a meeting and review the new system and data collection.
- 4. The new Transfer of Care module (FirstWatch) is being used in the field. Dr. Koenig will have input in the Medical Directors report.
- 5. Michael Barry has moved to the Veteran Affairs Office.

B. Medical Directors Report – Kristi Koenig, M.D.

- 1. Flu is widespread in California/we are closely monitoring incidence of ILI (influenza like illness) for stress to the EMS and other parts of the healthcare system. Not too late to get your flu shot!
- Love Your Heart is an annual event that will take place on February 14, 2017, during which the County of San Diego and its partners will provide free blood pressure screenings to the public at select sites throughout the San Diego region and Mexico. The goal of Love Your Heart is to activate residents to "know their numbers" and take charge of their own heart health.

In addition to getting your flu shot, know your BP!

- 3. Using a system called First Watch Transfer of Care, we are gathering data on off-load times. Data being reported are continuing to increase and improve in quality and issues are being activity addressed so please let us know if you are aware of any. We will be sending county wide reports, likely starting in March, and reporting next quarter's data to the State.
- 4. DA Strangulation Initiative (press conference last week); a women who has been strangled has a 7 fold increased chance of becoming a homicide victim. DA produced a PSA and a training video is in progress (filming tomorrow).
- 5. San Diego will be the site for the California State Trauma System Summit on May 2-3.

C. Agency Reports

<u>Lakeside Fire Department</u> - Bernard Molloy, D.C.

- Passed the milestone for 10,000 call mark in 2016 8% increase
- Were honored to be included in Sharp Grossmont's Magnate review
- Lakeside is hiring 4 new fire fighters. A lot of retirements continue to take place so we are in a constant hiring mode to replace those positions.
- Love your Heart is coming up on February 14th set up at the Lakeside Library.
- Some calls may be responded to by an ambulance specifically in El Cajon.
- Due to a new dispatch system Heartland fire is sending just an ambulance to some calls

Santee Fire Department - Justin Matsushita, D.C.

- Santee Fire Department is also hiring several fire fighters and paramedics.
- Just recertified all our Paramedics in ACLS. Grossmont was instrumental in helping us with that process.
- Our new ambulance should be arrive in June 2017
- Recently had a joint meeting between Santee and Lakeside paramedic committee meeting and discussed ways that we could collaborate.

A. Administrative Report – Adria Cavanaugh

Upcoming fee increase on July 1, 2017

- 1. Bad News is that the County Fee is going from \$17 to \$40
- 2. Good News is that we told you that this was going to happen early enough for you to make budget adjustments AND we told to it would be \$50, except at the last minute they made it \$40. SO far not much objection to the proposed reduction in fees.
- 3. Next year it will be \$66
- 4. The year after \$82
- 5. Sorry, But there were no changes since 1990 so we're feeling like this increase should be expected and not out of line with reality.
- 6. Remember we are committed to look at all the fees every year so other fee changes will be timely and in accordance with County Policy for true cost recovery.

CoSD LEMSIS

- We are aware that credentialing has suffered numerous delays. But we have added more personnel, working longer hours and have essential caught up with the April Back log and are already working on what we know will be a busy June
- 2. QCS and Bubble forms will be discontinued June 30, 2017. Any unused bubble forms should be returned to County EMS by July 14th.

Board of Supervisors:

1. The BOS approved a feasibility study last month for EMS to review the 4 large County "owned" EOAs and the 6 unserved areas which includes the Harmony Grove area. Recommendation will go back to BOS in October.

In late June the Board will consider some very routine CPI benefit fee increases in the County Services Areas (17 and 69). Communities impacted by these changes are Del Mar, Solana Beach, Encinitas, Rancho Santa Fe, Santee, Lakeside and Bostonia section of San Miguel.

B. Medical Directors Report – Adria Cavanaugh

- 1. Flu is widespread in California/we are closely monitoring incidence of ILI for stress to the EMS and other parts of the healthcare system.
 - 2. EMOC held a meeting at SDCMC on May 10 to address ED crowding and IT.
 - 3. San Diego will be the site for the California State Trauma System Summit on May 2-3.
 - 4. Measles Event

- A woman returning from travel to Southeast Asia presented to a local ED on March 8, and was ultimately admitted to the hospital, exposing others on the flights (March 6 and March 8) and at the health facility March 8 and part of March10 prior to isolation.
- Up to 470 contacts; First responder exposure tracking: several (~8-9) paramedics and/or EMTs were exposed; April 1 is the first day out of the incubation period for new cases

5. STAFF/ AGENCY REPORTS

A. Administrative Report – Jim Kirkpatrick

- 1. The County has declared a public health emergency for the Hepatitis A outbreak. As of September 12 there are 421 confirmed cases in the County, 16 deaths and 292 hospitalizations. The strain is most predominately within the homeless community and illicit drug users. The County is distributing hand washing stations in the area of the outbreak and reminds everyone to wash their hands. Healthcare workers are advised to wash their hands frequently and get vaccinated.
- 2. The CoSD LEMSIS (Local EMS Information System) is a patient electronic data collection program replacing the QCS system as of June 2017. Currently there is an excess of 70,000 calls entered into the system. The deadline for new agencies to submit their interest in joining LEMSIS is September 22, 2017.
- 3. The committee was advised that the Clerk of the Board of Supervisors recently notified EMS of two (2) CSA-69 open member positions for the Lakeside Community Planning Group (LCPG). LCPG was notified of the vacancy and asked to submit a nomination to ensure their representation on the CSA-69 Advisory Committee.

B. Agency Reports

1. Lakeside Fire District Report - Bernie Molloy

- a. Lakeside Fire public community outreach trained 100 people in CPR.
- b. Three (3) fire fighters were hired. Lakeside is preparing to hire paramedic fire fighters for CSA ambulances.
- c. A new medic van was ordered, received and returned as it had too small of a fuel tank. Diesel chassis are no longer available. Each ambulance puts on approximately 60,000 miles per year.
- d. Station 2 will have an open house on September 30th.
- e. In September there were 9,058 CSA-69 ambulances transports, a 3% increase over last year call volume. CSA-69 resources are at 91.9% compliance for August, Countywide compliance is at 38%.

2. Santee Fire Department – Justin Matsushita

- a. Job offers were given to four (4) new personnel.
- b. Santee red ambulances, fire trucks and engines are getting positive reviews.

C. Advisory Committee Member Report

1. San Miguel Fire Department

- a. The transition to return fire services back to the district is going well. Hiring will begin in January.
- b. An open house will be held on October 7. Station 19 is having a pancake breakfast on September 23, 8:00 12:00.

6. OLD BUSINESS

No old business to report.

7. NEW BUSINESS

Fifth Medic Unit Feasibility Presentation – Justin Matsushita, Bernie Molloy

A. Due to the increasing call volume and effect on CSA-69 resources, a study was completed on the feasibility of an additional medic unit for CSA-69. The presentation was to demonstrate a need, review the fiscal impact and discuss the feasibility of an additional medic unit in CSA-69.

B. Incidents per year

From 2011 to 2016 there was an increase of 29% in incident calls from 9,750 to 12,611. That is an increase of 29% and an average of 3,153 calls per medic units. The call volume for 2017 is estimated at 12,989 based on the projected 3% call growth.

C. CSA-69 Mutual Aid Statistics

1. Mutual Aid Incident Calls.

In 2016 there were 12,611 incident calls made in and out of the CSA-69 district. CSA provided 1,142 mutual aid transports into El Cajon; El Cajon provided 756 mutual aid transports to CSA-69. In 2017 the number of mutual aid incidents year-to-date are 9,058, with 1,046 CSA mutual aid calls into El Cajon and 513 mutual aid calls into CSA-69 by El Cajon. CSA-69 residents receive billing at a higher from El Cajon as a non-resident mutual aid transport.

2. Revenue and call increase.

With no additional revenue and a 3% growth in calls, new hire costs for firefighter paramedics, personnel, staffing and equipment needs will have an impact to the CSA-69 reserve by fiscal year 2018/19. Wittman provided CSA-69 collection information that shows if non-resident fees were increased to \$225 per transport which is below the County average, it would generate \$277,000.

3. Questions and discussion included capturing missed calls, closing the revenue gap for a neutral cost, and call density and location of new a medic unit. The following are two (2)

separate items to consider: 1) additional medic unit with a trial one year period alternating with Santee Fire and Lakeside Fire; and 2) a non-resident fee increase. CSA-69 non-resident transport fees are established by County ordinance.

4. Conclusion

EMS County staff requested to review and evaluate the study numbers, look at alternatives in the County budget as well as other models. A decision to move forward with the additional medic unit will be brought forward at the next CSA-69 meeting in November. There will be further discussion between County staff and the two agencies regarding the fee schedule budget proposal.
