4. MANAGEMENT TEAM REPORT

A. Budget and Finance Report - Sheri Shahri, EMS Admin Analyst

4. Budget Discussion/Questions and Input regarding defibrillators.

The monitor/defibrillators are being phased out by the manufacturer and will only be supported for a short time. As long as some current batteries issues can be resolved, they will remain serviceable until replaced. Putting aside \$500k in the budget for possible future replacements.

The Budget Subcommittee has reviewed the budget. A motion was made by Sherryl Parks to approve the budget for FY 18/19, seconded by Nancy Hillgren. Motion carried.

B. Budget Subcommittee Report – Andy Parr, EMS Administrator

The need for public access defibrillators is not specifically in the budget. An additional line item on this specific plan of operation for \$10-20k is being proposed.

Questions and answers on defibrillators

- Cost a little over \$1K each
- Will be located at businesses, libraries, schools, churches, community centers

Discussion to amend the budget.

- To set aside a range from \$10-20k for purchase of public access defibrillators. A column will be added to the proposed budget and be submitted for approval by the County Board of Supervisors.
- The money will come from the cash account (reserves).

A motion was made by Peter Zovanyi to set aside \$10k to get started and can later enhance that. Seconded by Mark Muir. Motion carried.

C. EMS County Report – Jim Kirkpatrick, EMS Fire Liaison

- Hepatitis A As of December 28, 2017, there have been no new Hep A cases. The Board of Supervisors ended the Public Health Emergency declaration.
- Influenza Due to the Influenza outbreak, we needed to raise our local capacity plan from Level 1 to Level 2. We have since returned to a Level 1.
 It's always possible for a second wave and we continue to monitor our data.
- Transfer of Care Monthly reports are now publicly available on the San Diego County EMS website. Quarterly TOC reports will be submitted to the State for public reporting on their website beginning in April 2018.
- County LEMSIS Data collection system is moving along very well. The next opportunity for agencies to come on board with the LEMSIS Elite product is June 19, 2018.
- Morphine shortage Morphine is our primary pain medication and we are currently experiencing a shortage. Most agencies are about 3-4 months from exhausting their supply. Most of the distributors are unable to provide a date of their next delivery. We are working in collaboration with the agencies. The EMS Medical Director has put out some guidance on how to deal with the shortage, providing some short term guidelines, interim guidelines and longer term plans to seek alternatives for pain medications in the field.
- Love Your Heart event A one day event held on February 14, 2018 for blood pressure screenings to be conducted throughout the county. The goal is to check as many blood pressures. Last year 20,000 people had their blood pressures checked, 53% of those had elevated blood pressure, and 77% of

those were already taking blood pressure medication. We encourage everyone to participate.

D. Paramedic Provider Report – Dave Austin, CSA Program Manager

CSA-17 4th quarter Performance reports for October, November and December were sent to the Advisory Committee members prior to the meeting. AMR performance reports were presented and included response time compliance, mutual aid and transport by community. Pleased to report another solid quarter.

- Flu shots were given, TB testing was done and Hepatitis A shots were also offered to anyone that was interested.
- Elfin Forest finally went ALS on January 23, 2018. They were one of the last areas of the region that were BLS.
- Working on ACLS, which is a mass cardiac life support and EMT recertification.
- Have an interim plan in place between the agencies while they have a vacated position for their EMS Coordinator.

5. **OLD BUSINESS**

• LAFCO – Harmony Grove Annexation Update – Andy Parr, EMS Administrator Harmony Grove was an area that was included in the Unified Service Area. However, after hearing from the community, consulting with the agencies, and consulting with the Supervisors from District 3 and District 5, it was decided that Harmony Grove be removed from the Unified Service Area, which did occur. It went before the Board of Supervisors in December 2017 and the USA concept plan was approved for RFP process to be awarded sometime in late 2019, and for operational service beginning January 1, 2020.

The Harmony Grove Annexation is currently on hold until we get further information from County Executives and the Supervisors in the area. Look forward to getting it back on the table and finishing it up.

B. EMS County Report – Jim Kirkpatrick, EMS Fire Liaison

1. Influenza – As of April 21, 2018, there have been 20,600 laboratory confirmed flu cases in the County with 341 deaths. Numbers have stabilized and we remain at an elevated level; no new ICU cases. The Public Health Officer has elected to not extend the flu mandate for our healthcare providers.

- 2. Pertussis We received a recent health alert on pertussis and rates are four times higher than the state rate. We are currently monitoring, but cases of pertussis may be on the horizon.
- 3. Transfer of Care (TOC) Data A reminder that this data has been posted on the County EMS website. The information will also be sent to the state and they will be posting on a quarterly basis.
- 4. EMS Fees Credentialing fees will be increasing effective July 1, 2018. Fees are currently \$40; will increase to \$63; following year will increase to \$83. We are still making efforts to reduce the fees by streamlining the process through the new LEMSIS system.
- 5. Opioid shortages Morphine was formerly our only pain medication, which became increasingly unavailable. Fentanyl was recently approved for pain management effective July 1, 2018. In addition, we received permission from the state to start delivering IV acetaminophen also effective July 1, 2018, as an option if agencies are having difficulty obtaining either opioid. We are currently pursuing ketamine as another alternative for paramedics to give out in the field. We are actively searching alternatives while we face these shortages.
- 6. New EMT skills are being rolled out state wide. Effective July 1, 2017, EMTs were given additional skills; naloxone for opioid overdoses, epinephrine for allergic reaction emergencies and blood glucose testing.
- 7. Sidewalk CPR event Many agencies will be providing Sidewalk CPR training on May 17, 2018 from 10:00 am 4:00 pm. The public is encouraged to stop by to receive a quick lesson on hands-only CPR training. Very useful and effective tool.

Questions and answers:

- Credentialing fees for EMTs are covered by the employer.
- CPR locations will be posted on each agencies' website. County EMS will
 check if there is a single website listing all CPR locations.
- The latest general use of narcan is it is still a prescription medication.
- The mandate influenza order for health care workers required them to have a flu shot or wear a mask.

C. Paramedic Provider Report – Dave Austin, CSA Program Manager

- In the Set aside for possible capital improvements in 18/19 budget included 500k for monitor defibrillators

4. Budget Questions, Concerns and Discussion

The advisory committee had several questions during the FY 17/18 Financial Review presentation, for which the county staff made note of and indicated they would research to provide answers. County staff suggested, moving

forward, benefit fees could be addressed as a key item in presentations prior to the Board of Supervisors approval. The committee also expressed concern regarding the excess balance above the required reserves in the budget.

Action Items:

- 1. The advisory committee members will submit a letter and ask for a response by a certain date.
- 2. A request was made to schedule a Special Meeting (subcommittee meeting) to include Mark Muir, Sherryl Parks, Peter Zahn and County staff.

B. EMS County Report - Diane Ameng, QA Specialist

- Stop the Bleed Program The County is adopting this program to place stop the bleed kits throughout county facilities. It is currently in the process of the implementation.
- Sidewalk CPR event occurred in May which resulted in 2001 people trained in Hands Only CPR, 235 within the CSA; 85 at Rancho Santa Fe Library, 78 at Seaside Market and 72 at Forest Ranch Library. There was an increase from last year.
- 3. Notifications A new email address has been established to advise EMS leadership of important, but not necessarily urgent or emergent information, such as when resources are leaving the county.
- 4. County EMS fees changed effective July 1, 2018. EMS started a three (3) step increase for accreditation for new paramedics, EMTs and Mobile Intensive Care Nurses (MICNs). Fees increased from \$40 to \$63. Next year will go from \$63 to \$83.

C. Paramedic Provider Report – Dave Austin, CSA Program Manager

1. CALL TO ORDER/ PLEDGE/ INTRODUCTIONS/ ANNOUNCEMENTS

- **A.** Don Heiser, CSA-17 Vice-Chair called the meeting to order at 4:00 pm.
- **B.** Pledge of Allegiance.
- C. Introductions were made. Cory Osth was introduced as a new member to the management team with County EMS, overseeing hospital and specialty care programs. He comes from the County Office of Emergency Services.

2. PUBLIC COMMENTS/PETITIONS

There were no public comments or petitions submitted.

3. APPROVAL OF MINUTES

A motion was made by Peter Zovanyi seconded by Nancy Hillgren to approve the August 7, 2018 CSA-17 Advisory Committee minutes. Motion carried.

4. PRESENTATIONS – Lifeguard Programs

- City of Encinitas Larry Giles, Safety Captain, presented on the Marine Safety Division.
- City of Solana Beach Jason Shook, Marine and Safety Captain, presented on the Marine Safety Department.
- City of Del Mar John Edelbrock, Lifeguard Chief and Director, presented on the Community Services Department.

5. MANAGEMENT TEAM REPORT

A. Budget and Finance Report – Robert Bechtol, EMS Admin Analyst

1. The <u>CSA-17 Financial Review Q1 FY 18-19</u> was presented, which covered the following: Revenue Growth by Source, Expense Growth by Source, Budget, Reserves, Monthly Transports, and Collections.

Clarification on last quarter's presentation: In the Billing & Collection Services, there was a 14% change. However, it was actually a 6% change after all the invoices were reconciled. One of the invoices from FY16/17 was counted in the FY 17/18 because it was paid in FY 17/18.

The data was pulled early to get to everyone timely:

- Revenue Growth by Source Resident and Non-Resident Transport Fees
 decrease of 16 and 17%
- Expense Growth by Source Billing and Collection Services = down by 50%
- We are using a 2.09% revenue increase from year to year and a 2.2% increase in expenditures each year as well.

2. Review Budget Process for CSA-17 and Next Steps:

A new process has been rolled out in the hopes of meeting the needs of the advisory committee. The process has been moved up a month: 1) County EMS staff meets with the operations chiefs who are planning the agenda a month in advance of the meeting day. 2) County EMS staff works with the Chair and Vice-Chair two weeks later to set the agenda and get it out to the Chair and Vice-Chair for their approval. (3) Once agenda is approved, County EMS staff sends out the agenda and handouts to the advisory committee in advance for the committee to review prior to the meeting.

Our plan on the budget process (over the next few months): Robert Bechtol met with the operations chiefs today and went over the early part of proposed budget and budget timelines. The operations chiefs were given a worksheet to work from for any additional requests going forward. Once the worksheets are returned to us, Robert will create a draft budget and meet with the operations chiefs in December and again in January. The draft budget will be presented at the next budget subcommittee.

 Sherryl Parks and Don Heiser have been identified as the budget subcommittee members. The proposed hearing date for the next budget subcommittee meeting is January 29, 2019.

B. EMS County Report – Jim Kirkpatrick, EMS Fire Liaison

- 1. The flu order went into effect November 1, 2018 through March 31, 2019, which is the County Health Officer order mandating an influenza vaccine or wear a mask while in contact with patients or working in patient care areas.
- 2. The updated Capacity Plan, now known as the All-Hazard Health Services Capacity Management Plan has been updated to ensure a planned, systematic response to prehospital and hospital capacity stress. This plan was originally developed to address flu season; it has now evolved to emphasize "all hazard" event management. We began monitoring data on a weekly basis and very soon anticipate monitoring on a daily basis as we get deeper in the flu season.

3. New Regulations

- EMS for Children regulations are available for public comment until November 10, 2018.
- Local optional scope of practice application to add ketamine as a pain medication option has been approved. A July 1, 2019 start date is anticipated.

C. Ground Ambulance Provider Report – Dave Austin, CSA Program Manager

The <u>CSA-17 4th quarter AMR Performance Reports for July, August and September</u> were sent to the Advisory Committee members prior to the meeting and were presented at the meeting. Highlights included: response time compliance, mutual aid, transport by units and community, community service and public and continuing education. Pleased to report another solid quarter of compliance overall.

Zach Smith shared information and data on cardiac arrest survival. Nationwide it remains very low at 8%, in CSA-17 12.7%.

D. Operations Chief's Meeting Report – Jon Blumeyer

- Encinitas, Solana Beach, Del Mar and Rancho Santa Fe have applied regionally for the Assistance Firefighters Grant (AFG) for ballistic body armor for hazardous scenes for their firefighters and adding this to their risk profile.
- Meeting with Rancho Santa Fe to discuss CSA budget to look at ways to utilize some of those monies to better serve the community and what programs or purchases would be most effective.
- In line with CPR survival rates; continuing to look forward in our process to increase the number of AEDs out in the community, and putting them in command vehicles.

6. OLD BUSINESS

• LAFCO update – No movement on the County's part. No additional information to report.

7. NEW BUSINESS

- Tony Michel, Fire Chief of Rancho Santa Fe Fire Protection District, will be retiring in mid-November. A proclamation from the Board of Supervisors has been requested.
