B. Budget Discussion – Sheri Shahri, EMS Admin Analyst

1. Presentation of the Proposed 19/20 Budget

The <u>CSA-17 Budget Presentation FY 19-20</u> Power Point was provided and covered the following: Budget for Approval and Vote, Cash Balance Projections.

Budget Questions/Discussion:

- The FY19/20 budgets for City of Del Mar, City of Encinitas, Rancho Santa Fe, City of Solana Beach, North County Dispatch, AMR, Wittman Enterprises, Sacramento Fire, Wildan, County Costs, and Mutual aid.
- CSA business consultant- actual contract amount unknown as of the date of the presentation. Will update contract amount once contract is signed.
- Monitor/Defibrillators, Public Access Defibrillators and One Time Startup for Auto-CPR's
- High reserves balances declining, and projections show Excess Cash completely used as of FY28-29
- Reducing transport costs
- Cash Balance Projections

2. Budget Subcommittee Report

The chiefs have put together a proposed budget which includes increasing the amount that each agency gets to provide better service to the communities with a total of \$234,400 distributed between the four agencies. This includes managing programs such as EKG monitors, auto pulse devices, placement of AEDs, community CPR, improving communication systems, getting lifeguards involved, increase training such as active shooter, and a proposal for the Medical Director that would support the north zone agencies.

REQUEST: Joe Mosca requests additional information on the expenditures prior to the meeting.

A motion was made by Nancy Hillgren, seconded by Barbara Cerny to approve the FY19-20 Budget. Motion carried.

C. Current Year Financial Discussion – Sheri Shahri, EMS Admin Analyst

1. Presentation of the 18/19 Q2 report

The <u>CSA-17 Financial Review Q2 FY 18-19</u> Power Point was presented, which covered the following: Revenue Growth by Source, Expense Growth by Source, Monthly Resident and Non-Resident Transports and Collections.

Questions/Discussion: Declination in transports YTD FY18/19 vs. YTD FY17/18.

A motion was made by Nancy Hillgren, seconded by Barbara Cerny to approve the Financial Review Q2 Report FY 18-19. Motion carried.

D. EMS Section Report – Andy Parr, EMS Administrator

- 1. Health Services Capacity Task Force meets on a regular basis to see the All Hazards impact of surge on hospitals. It is a five level plan, with Level 1 being the highest, representing severe disaster and Level 5 being the lowest, representing a normal base line. This year we are steady at Level 4 with daily surveillance. All ambulance providers are encouraged to be diligent on their collection of care data.
- 2. Love Your Heart Day February 14, 2019 an annual event in which organizations from across the U.S. and Mexico join together to provide free blood pressure screenings to the public. Locations are posted on the website at loveyourheartsd.com
- 3. The contract between the county and the agencies includes the county providing a Medical Director, Dr. Kristi Koenig. She also serves as the CSA-17 Medical Director.

E. Ground Ambulance Provider Report – Dave Austin, CSA Program Manager

- The <u>CSA-17 Quarterly Performance Reports for October, November, and December</u> were sent to the Advisory Committee members prior to the meeting and were also presented which covered: Response Time Compliance, Mutual Aid/Auto Aid Summary Reports, Transports to Hospitals by Units and by Community. Pleased to report another solid quarter of compliance overall.
- 2. Community Service and Public Education: For the quarter, completed 255 hours, with 2,095 served of which 886 were CPR trained.

 - AED training
 - o BP screening
 - o Child car seat inspections
 - Ambulance show and tell
- 3. CARES Cardiac Arrest Registry to Enhance Survival
 - o National for 2017 10.4% survival rate

 - o Public AED used 14.3%
- 4. Multi Year Cardiac Survivor Luncheon

- 5. Continuing Education: Quarterly CE continues to be provided by Zach Smith and Guest Lecturers with the support of the Training Chiefs.

- 6. Awesomeness On The Street, an AMR case review document by Dr. Brad Schwartz was provided to read of unusual cases that are seen, but that paramedics may not encounter every day.

F. Operations Chief's Meeting Report – Dave McQuead, Deputy Chief RSF FPD

- 1. Hiring all agencies are going through succession planning
 - Solana Beach one (1) new personnel
 - o Rancho Santa Fe two (2) new personnel in April
 - o Encinitas one (1) new personnel
- 2. Training Active Shooter
 - o As first responders, we must have a strategic plan
 - San Marcos had an active shooter drill at Cal State San Marcos, North Zone agency participation
 - Del Mar will be doing an active shooter drill
- 3. Agency Difference

Rancho Santa Fe does not have a beach but has a lot of trail systems, and a course for marathons. The fire fighters have gotten together, gone out to the reserves and through the trails, and have worked with County copters with hoisting mechanisms to be prepared in the event that they have to extract a patient that may be miles away from a road.

V. OLD BUSINESS

LAFCO Update – Andy Parr

- No change.
- o For the new members, this is a long standing issue regarding property tax negotiations for annexation of CSA-17 to the Harmony Grove area. The Advisory Committee is not interested in annexing the area without a property tax negotiation that is fair and equitable to the rest of the people in the CSA. The County's position doesn't believe a property tax negotiation is necessary because the fees associated with users of this service more than pay for the service in those areas. Harmony Grove is growing quickly and there is a desire to figure this out.
- A <u>Harmony Grove Power Point presentation</u> was provided that covered: Ground Ambulance Operating Areas, Harmony Grove Ambulance Operating Area, and Practical Differences.

Questions/Discussion

Transport fees and comparison to current market rates; property taxes and benefit taxes.

Frank Twohy, resident of Elfin Forest and Harmony Grove, spoke on behalf of the community. The community feels that CSA-17 would be a better provider, however the funding is confusing to the community.

RECOMMENDATION/ REQUEST by Nancy Hillgren: As a high priority, have the new consultant do a thorough analysis, one with an ambulance, and the other without an ambulance to compare what the long range cost impact is. Nancy would like the members to be able to listen to the Harmony Grove and Elfin Forest residents who are directly affected.

A chart was provided of members and their terms. Members have indefinite terms; Members at Large have two year terms, which have expired.

III. APPROVAL OF MINUTES

IV. MANAGEMENT TEAM REPORT

A. Budget, Financial and Cost of Living Adjustment (COLA) Report – Sheri Shahri, EMS Admin Analyst

The <u>CSA-17 Financial Review Q3 FY 18-19</u> was presented, which covered the following: Benefit Fees, Revenue and Expense Analysis, and Reserves/Cash Analysis.

1. Budget Trending

Benefit fees are scheduled to increase by 3.37% and will be effective July 1, 2019.

2. Budget Discussion/Questions

Many questions were asked regarding the consultant. There were discussion/questions, concerns and input regarding the reserves, subsidized services, projections, and analysis in general.

A request was made that the consultant be in attendance at the next meeting in August to answer questions regarding who they are, where they are going, their charges, what they are asked to do, and any critical info they can share that the members can comment on.

A motion was made by Peter Zovanyi, seconded by Joe Mosca to accept the Q3 Financial Report. Sherryl Parks opposed.

A motion was made by Peter Zovanyi, seconded by Barbara Cerny to accept the COLA Report. Sherryl Parks opposed.

B. EMS County Report – Andy Parr, EMS Administrator

- 1. Surveillance
 - a. Flu Flu is on the decline. Per the May 1st report: 9,287 total cases, 67 deaths, 26 outbreaks (last season 20, 735 cases, 341 deaths). The extension of the health officer flu order through April 30th has not been extended. The Health Services Capacity Task Force All-Hazard Management Plan has returned to Baseline (lowest) level.
 - b. Measles At this time there are no documented cases in San Diego, however it only is a matter of time. There have been cases in Los Angeles and Orange County and most have been associated with international travel. Agencies may want to consider requesting immunization records for the providers to determine staff who may need to receive the MMR vaccine.
- Patient Tracking San Diego County EMS and the Public Health Preparedness and Response Branch are in the process of designing, building and implementing a Patient Tracking system in conjunction with the San Diego Healthcare Disaster Coalition.
- 3. Upcoming Procurements Information regarding upcoming procurements can be found on the County of San Diego EMS website. These include 9-1-1 Advanced Life Support Ambulance Services for the National City Operating Area, San Marco Operating Area and the Unified Service Area. The Unified Service Area procurement will include three distinct areas in one procurement; Inland North, Inland Central and Inland South.

- 4. Sidewalk CPR County EMS would like to thank our community partners for their participation in Sidewalk CPR. This year the County of San Diego EMS has elected to make a change in the way Sidewalk CPR is provided throughout the County. Rather than selecting one day, each agency or organization may select the day (or days) that they believe would reach their targeted audience of participants. All training totals, if the agencies elect, can be shared with County EMS in order to report on the number of hands-only CPR trained individuals in San Diego County.
- 5. Stroke Awareness Day This year's event is on May 19th against the Pittsburgh Pirates. Discounted tickets are available at https://www.mlb.com/padres/tickets/specials/strike-out-stroke. Members of the Stroke Consortium will staff informational booths at the event promoting stroke prevention and recognition. Stroke survivors will also be recognized on the field prior to the game.
- 6. Policies and Protocols
 - a. Ketamine We remain on track for ketamine implementation for analgesia, effective July 1. Reminder that IV acetaminophen is approved for treatment of pain and NOT for fever.
 - Stroke and STEMI Policies will be reviewed this month at EMCC updated to reflect new regulations. Policies will be effective July 1.
 - c. BLS Providers AEDs, glucometers, epinephrine auto-injectors, and intranasal naloxone will be required as of July 1.
 - d. Paramedic Regulations Are currently open for comment until May 20. This information is available on the EMSA website at www.emsa.ca.gov
 - e. Fees The Board of Supervisors have approved the 2019-2020 fee structure for personnel, agency, and hospital designation fees. The approved fees are the same as the proposed fees presented to EMCC in March. For personnel fees, the County fee has increased from \$63 to \$86. Agency and hospital designation fees will be posted on the EMS website.

C. Ground Ambulance Provider Report – Dave Austin, CSA Program Manager

- CSA-17 Quarterly Performance Reports for January, February and March 2019
 were sent to the Advisory Committee members prior to the meeting and were also

I. CALL TO ORDER/ PLEDGE OF ALLEGIANCE/ INTRODUCTIONS/ ANNOUNCEMENTS

- **A.** Don Heiser, CSA-17 Chair called the meeting to order at 4:04 pm.
- **B.** Pledge of Allegiance.
- **C.** Introductions were made. Robbie Ford was introduced as the new Deputy Chief for Encinitas, Solana Beach and Del Mar Fire Department.

II. PUBLIC COMMENTS/PETITIONS

There were no public comments or petitions submitted.

III. APPROVAL OF MINUTES

A motion was made by Sherryl Parks seconded by Kelly Harless to approve the May 7, 2019 CSA-17 Advisory Committee minutes. The motion passed with four (4) votes in favor and one (1) abstain.

IV. CORRESPONDENCE

a. California Fire Chiefs and Fire Districts Association

AB1705 endorsement. The County takes no position on this at this time.

V. SUNSET REVIEW – County (BOS Policy A-74) requires review and validation of all County Advisory Committees.

A sunset evaluation occurs on a scheduled basis, every four (4) years, to determine effectiveness of the committee and the need for its continued existence. This Committee is being asked to provide data on costs, benefits, committee composition and other committee information. It is recommended that the Advisory Committee take action to reauthorize for another four (4) years.

A motion was made by Peter Zovanyi, seconded by Kelly Harless to continue the CSA-17 Advisory Committee. Motion carried.

ACTION: County EMS staff will sign the document and forward for processing to the County Clerk of the Board's office.

VI. MANAGEMENT TEAM REPORT

A. Budget and Financial Report – Mike Iacona, Consultant, CPSM

The <u>CSA-17 - FY 2018-19 4th Quarter - Year End Totals</u> report was presented, which covered the following: Revenue, Expense, Unit Costs (Revenue and Expense), Operations Analysis, Reserve Analysis.

1. Budget Trends

- Revenue reduced by roughly 1.5%
- Expenses up approximately 8%
- Unit Costs revenue was down slightly; expenses up nearly 10%
- Net from Operations reduced by 49%
- Reserve Analysis up 1%

2. Budget Preparation/Process

Budget planning cycle begins this August. The budget was approved at the February meeting. The agencies have already submitted their requests, budgets have been funded, and are working on the new figures for this current budget year 19/20. County EMS is preparing to come to this committee and to the Fire Chiefs Meeting in November. With additional budget information, County EMS will work with the Chiefs carefully at their monthly Operations meeting in December to help them fill out any additional budget requests or amendments to their current 5-year budget. County EMS will meet with the Chiefs in January to go over that budget

and prepare a budget for the board to review at the February 2020 meeting. A Budget Subcommittee meeting will take place, if necessary, in late January.

ACTION: A request was made to have the figures to the Advisory Committee early enough to ensure the budget is healthy. Andy Parr has offered to bring the 4th year of the 5-year budget for their review in November, but wants to ensure the Chiefs have adequate time to make any requests or adjustments for their input and advice.

ACTION: A request was made that the lifeguards be included in this process and that an attempt be made with our current budgeted funds. Chief Stein will meet with County EMS to discuss this topic between now and November.

B. EMS County Report – Andy Parr, EMS Administrator

- Measles At this time there are no documented cases in San Diego, however it is
 possible that this will change. There have been cases in Los Angeles and Orange
 County and most have been associated with international travel. Agencies may
 want to consider requesting immunization records for the providers to determine
 staff who may need to receive the MMR vaccine.
- 2. HSCTF Is in the process of the routine summer editing. We recently added two new members representing the County Fire Chief's Association. The HSCTF assists the county and the hospitals in monitoring the health of the EMS delivery system and the core group makes recommendations to the Chief Medical Officer to adjust the plan in order to liberate additional tools in times of stress to the capacity of the system.
- 3. Procurements County staff continues to work diligently on three procurements in the County. This is a huge volume of work and we're nearing the finish line on some of this work soon. Information is available on the County's Purchasing and Contracting website through the BuyNet link.
- 4. Policies and Protocols New protocols went into effect July 1. Reminder that ketamine must be administered SLOWLY IV and is NOT approved for use for treatment of agitation or for drug-facilitated intubation.
- 5. Agencies with EMTs, AEDs, glucometers, epinephrine autoinjectors, and intranasal naloxone will be required on BLS ambulances as of July 1, 2019. Some providers have had difficulty obtaining EpiPens; we are handling this on a case by case basis with those agencies.
- 6. Fees The Board of Supervisors have approved the 2019-2020 fee structure for personnel, agency, and hospital designation fees. The approved fees are the same as the proposed fees presented to EMCC in March. For personnel fees, the County fee has increased from \$63 to \$86. Agency and hospital designation fees will be posted on the EMS website shortly.

- The budgets have an annual built-in 3% price escalators. FY 19/20 includes capital purchases of monitors, public access defibrillators and CPR devices.

- Today's item on the agenda asks the Advisory Committee to consider the need to hold a CSA-17 Budget Subcommittee meeting in January.
- County EMS staff suggested that since the budget amount was previously agreed upon by the agencies, and there are no edits or amendments offered by the agencies to consider, that a Budget Subcommittee for this year could be omitted.

B. EMS County Report - Andy Parr, EMS Administrator

1. Health Services Capacity Taskforce (HSCTF) – developed the capacity Plan, a document that County EMS produces each year, which addresses the level of concern or emergency for different health capacities in our emergency departments. Currently at Level 5, which is the lowest. It drives a lot of our decisions on how much emergency capacity there is not only in our emergency departments, but also for our ambulance providers for our upcoming flu season.

2. Public Health Officer Letter Flu Letter – Is the same letter as last year and remains in effect until it is rescinded or superseded. It requires paramedics or EMTs who are not vaccinated for the flu to wear a mask to prevent the spread of the flu or any other disease when they are in the presence of patients. It cuts down the ability of spreading the flu.
