City of San Diego Pilot

- With the Falck transition, filled four community paramedic positions, a physician assistant and an RN.
- Getting two new fire fighter community paramedic positions.
- The regs will probably be implemented on October 1st; will run a community paramedic education program under the pilot structure in July and August; 150 hours minimum.

One participant from the pilot is deceased. Was on waiting list for two months. Lost his location. Was notified by his family of his death. Still waiting for information from them to obtain cause of death.

Anne Jensen and Brian Christison did go in depth on the document. Overall, much improved from the previous version.
