I. CALL TO ORDER/INTRODUCTIONS/ANNOUNCEMENTS

Dr. Weinstein called the meeting to order at 10:59 a.m.

II. APPROVAL OF MINUTES

A motion was made and seconded to approve the January 15, 2019 minutes. Motion carried.

III. COUNTY REPORT (Kristi Koenig, MD)

A. Surveillance

- 1) Flu update published 02/13/19
 - 4,423 cases, 30 deaths, 7 outbreaks
- 2) Jury Duty Letter last year will provide as it is not needed for requesting jury duty deferral
- 3) Met triggers for enhanced surveillance on capacity plan
 - Moved from baseline level 5 to enhanced level 4 (due to respiratory complaints and ED bypass)
- 4) Ebola outbreak in DRC declared August 1, 2018
 - CDPH CAHAN Feb 15
 - WHO reports 829 confirmed and probably cases and 521 deaths
 - Remember travel history!
- 5) Measles outbreak CDC confirmed > 100 cases in 10 states
 - WHO reporting substantial case increase with outbreaks in > 40 countries https://www.cdc.gov/measles/cases-outbreaks.html

- 1) Remain on track for ketamine implementation on July 1, 2019 reminder to push SLOWLY IV
- 2) Reminder that IV APAP is approved by the State for analgesia, not for fever

- 1) EBM presentations posted on line at medical director page today's talk is on prehospital sedation of the agitated patient

- 2) Unified Optional Scope of Practice for CA within Qualified Transport Programs
 - CoSD applied and participated in Scope of Practice Committee meeting on 02/12/19 Committee recommended approval of our application; ending official authorization from EMSA medical director
 - Six procedures included in unified optional scope (all or none)
 - o Pediatric Intubation
 - RSI (rapid sequence induction)
 - Video laryngoscopy (indirect laryngoscopy)
 - Supraglottic airway devices
 - o Ventilator initiation, maintenance and management
 - o Intraosseous (IO) access for adult and pediatric patients
- 3) CAC report need for real time 12-lead EKG transmission to receiving hospitals
- 4) Migrant Caravan update
 - Protect the health of the public, including families seeking asylum, by conducting health screening assessments in the setting of the San Diego Rapid Response Network shelter(s), and referring for outside medical care as appropriate.
 - Only a handful of 911 calls to the shelter
- 5) Human Trafficking arranging for a future speaker
- 6) Strangulation CAHAN Health Advisory 02/12/19
 - i. Strangulation differs from choking

- ii. Only 4 pounds of external pressure to occlude the jugular veins; only 5-11 pounds of pressure to occlude the carotid arteries; unconsciousness can occur within seconds and death within 3-5 minutes
- iii. Victims with no or minimal external signs of trauma may have life-threatening internal injuries such as carotid or vertebral dissections or fractured hyoid bones
- iv. Non-fatal strangulation is a risk factor for future homicide
- v. Can see strokes in young people, however strangulation domestic violence affects all ages from kids to grandmothers

- 7) On Feb 14, CMS announced future pilot project for reimbursement for transport to alternate destinations.
 - i. The Center for Medicare and Medicaid Innovation's (Innovation Center) Emergency Triage, Treat, and Transport (ET3) Model is a voluntary, five-year payment model that will provide greater flexibility to ambulance care teams to address emergency health care needs of Medicare beneficiaries following a 911 call. Under the ET3 model, the Centers for Medicare & Medicaid Services (CMS) will pay participating ambulance suppliers and providers to 1) transport an individual to a hospital emergency department (ED) or other destination covered under the regulations, 2) transport to an alternative destination (such as a primary care doctor's office or an urgent care clinic), or 3) provide treatment in place with a qualified health care practitioner, either on the scene or connected using telehealth.
