#### I. CALL TO ORDER/INTRODUCTIONS/ANNOUNCEMENTS

Christopher Wiesner, M.D. called the meeting to order at 11:00 am.

#### II. APPROVAL OF MINUTES

A motion was made and seconded to approve the minutes from May 16, 2017. Motion carried.

#### III. COUNTY REPORT (Susan Smith, R.N. & Dean Sidelinger, M.D.)

- A. County of San Diego continues to monitor the Hepatitis A outbreak, occurring primarily in the homeless population. To date there have been 181 cases recorded, with 4 deaths. The median age of those affected is 42. The County is conducting an outreach, with public health nurses going out into the community to offer vaccinations. Providers are urged to contact San Diego County Epidemiology while suspected cases are still at the healthcare facility.
- B. The County is closely monitoring several drug shortages. A letter recently went out to agencies and base hospitals outlining alternatives to drugs currently in shortage.
- C. It is important that POLST forms are brought to the hospital with the patient.
- D. Sidewalk CPR took place on May 19, 2017. Agencies throughout the County took part, resulting in the training of a total of 2,124 people at 24 locations.
- E. The PCR for LEMSIS was rolled out on June 6, 2017. Resource Bridge training will take place today and tomorrow.
- F. QCS and the bubble forms will be officially discontinued on June 30, 2017.
- G. The protocol updates, training and clarifications have been sent out.
- H. The Board of Supervisors has approved a certification fee increase from \$17 to \$40, beginning July 1, 2017.
- I. Effective July 1, 2017 at 0800 the County of San Diego, Emergency Medical Services (EMS) is relocating the Air Ambulance Designated Dispatch Center from its current location at American Medical Response, San Diego Communications Center, to CALFIRE/San Diego County Fire Authority's Monte Vista Emergency Command Center (ECC).
  - \*Dr. Grad was thanked for her service to BSPC. This is her last meeting and her replacement will be Dr. Karl Marzec.

#### IV. SAN DIEGO HEALTH CONNECT

The Search, Alert, File and Reconcile (SAFR) system is now live in San Diego.

Search: there are currently about 1400 searches/day with approximately 60% showing exact matches. All problems, allergies, meds and encounters are transmitted to the EMS hub. The EMS hub searches for a patient match. When a match is found, the info is relayed to the facility. There are approximately 300 HIE requests/day.

Alert: at the scene and during transport. The narrative from the paramedic is live streamed to the ED. The information is being sent successfully about 90% of the time.

File: the paramedic finishes the report. The information is being sent successfully close to 100% of the time.

The State Health Information Guidance (SHIG) system allows the sharing of behavioral health information within California. The guidance document will be published in July 2017 and will be available at <a href="https://www.chhs.ca.gov/ohii/pages/shig.aspx">www.chhs.ca.gov/ohii/pages/shig.aspx</a>.

<u>S-412</u>-the definitions and language in S-412 and S-415 are now matching in the areas of designated decision maker and emergency patient.

<u>B-450</u>-effective July 1, EMSA has issued new EMT regulations. These recent changes are not expected to be in the protocol changes for this cycle since they were just approved.

- III E "Standard Radio Report-A problem-oriented verbal communication which includes..."
- III F "LEMSIS radio report-A modified verbal report given to the Base Hospital MICN when connectivity allows data to be electronically transferred in real time to the Base Hospital."
- IV A "EMT shall call Sharp Memorial for pediatric patients who meet trauma center criteria (T- 460)."
