<u>The CSA-17 FY 2019-2020 Financial Overview & Projections</u> was presented by Tom Wieczorek from the Center of Public Safety Management (CPSM), which covered the following: Revenue, Expense, Operations Analysis, Reserve Analysis, and Projection.

The new billing agency is R1/RCM.

i. Accept the Q1 Financial Report

ACTION: A motion was made to move to accept the Financial Overview Report with the understanding of questions to answer 1) the comparison of payor mix between CSA-17 and CSA-69 and any other applicable payor mixes readily available, and 2) provide the break down of total call volume in ambulance transports for July and August for Jody Hubbard, between now and the next meeting. Motion carried.

#### C. EMS County Report – Andy Parr, EMS Administrator

- 1. EMS Agency Report COVID-19 shut down entire office. Staff is teleworking from home since end of February. A few staff are at the County's Emergency Operations Center (EOC). CSA activities, billing, contracts stayed on track. Policies and procedures continue. Medical Director ensured first responders had access to information regarding COVID-19, such as providing FAQs on the EMS website.
- 2. COVID-19 Response continues. The EOC is still active with almost 400 people working seven days a week. Has been a delicate situation between counties, cities, states, schools. All impacted in a different way.
- 3. Out of District Transport Fee Update initiated and approved out of district transport fee. Still progressing.

- 5. LEMSIS Data Presentation Josh Smith shared two live dashboards. Live database; CSA can designate access. The intention of this dashboard is for Chiefs to present. Josh needs list for who should have access. Andy Parr will work with Chief Cox and Chief Stein and for CSA supervisors.

#### D. Ground Ambulance Provider Report – Dave Austin, CSA Program Manager

1. CSA-17 Quarterly Performance Reports for October, November, December 2019 were sent to the Advisory Committee members, as well as the Annual Report for 2019, Awesomeness On The Street, and an American Heart Association 2020 Mission: Lifeline EMS Recognition. The Quarterly

Performance Reports were also presented which covered: Response Time Compliance, Mutual Aid, Transports by Community. Pleased to report another solid quarter of compliance overall.

## E. Operations Chief's Meeting Report – Dave McQuead

- Conducting CSA-17 EMS Coordinator interviews.
- Rancho Santa Fe received a grant through San Diego Regional Fire Foundation to purchase extrication tools for Station 6, which allows to enhance capabilities for vehicle accidents.
- Del Mar Fire hired 1 firefighter paramedic; Solana Beach hired 1 firefighter paramedic; Rancho Santa Fe will hire 1 firefighter paramedic.
- Blending the two situations of COVID-19 and dealing with the state of California on fire. Main concern is ensuring personnel well equipped; taking every precaution while performing fire suppression activities; maintaining social distancing and other hygiene factors.
- Robbie Ford thanked AMR partners for effort and cooperation in fairgrounds for the fire protection drive thru event happening. Looking for every opportunity and grateful to have face time with the community.
