B. County Report - Andy Parr

1. EMS Agency Report

 Policies and Protocols: Annual protocol changes are on track. Did not make them last year in the middle of the COVID pandemic, therefore there are two years worth of changes and the 2021-2022 protocols are finalized. Education materials are being prepared and distributed for the July 1 effective date. If you did not receive the final protocol PDF packet and would like to review, please email County EMS. Protocols will be posted to the EMS website just before the effective date.

- Assess and Refer program has been discontinued as of April 30, 2021.
- COVID-19 EMS Waiver Reporting Reminders for P-801 will be going away on July 1, 2021.
- EMS Agency thanked the Fire Chiefs and organizers of the County Wild Land Drill. We were able to respond and work within scenario for activating our hospitals to notify them that there was a fire and injuries, etc. We used our LEMSIS system which is in every one of the 22 hospitals. Most of our agencies share resources that could be used to notify agencies and hospitals.
- Working closely with Scripps IT regarding the outage. Was problematic for many.
- Annual Annex D review is being updated. This is a multi-casualty plan.

C. Operations Chief's Meeting Report

Lakeside Fire District Report – Bernie Molloy

- 1. CSA 69 paramedics involved with the vaccinations going on throughout the County, continues and is ongoing.
- 2. Both workforces are well vaccinated.
- 3. Hired four in the academy.
- 4. Had shortages due to the pandemic; one of the shortages was the availability to go with their regular ambulance which is a van chasse. Switched to a truck chasse, which is a better platform, about the same price and will continue to go with truck chasses in the future.
- Discussed call statistics of 2019 pre-pandemic, during pandemic, and post-ish pandemic. Saw a drop and now back up above where we were. It has been slow and steady.

Santee Fire Department – Justin Matsushita

- 1. Hired six new staff, going through various onboarding phases.
- Some personnel for the Operation Collaboration are split between Santee and Lakeside. They have put a lot of time in and looking forward to that spooling down and having them shift back to their primary focus working within our agency.
- 3. Will be going to a new vendor for materials and supplies with a significant cost savings. New vendor is Life Assist effective July 1. Will provide same service.

VI. OLD BUSINESS

A. Consultant's Report on CSA 69
Matt Zavadsky provided a PowerPoint presentation CSA 69 Draft White Paper Report
which covered findings and recommendations, and was followed with discussion and Q
and A.

The recommendation is to dissolve CSA 69. Chief Administrative Officer for the County of San Diego, Helen Robbins-Meyer, will receive the report and make the final decision along with input and advice from District 2.

B. Out of District Transport Fee Report
