A. Prehospital/Hospital Subcommittee - Chara Cote, RN

The group met. 1) Discussed a new Policy S-882: Dispatching of Emergency Medical Services;. The committee is requesting further public comment. 2) Discussed Policy S-TBD: Combined First Responder Inventory; not ready yet; will see it in January. 3) Discussed developing a workgroup to update the MCI Policy by EMS section.

B. Education and Research Subcommittee - Cheryl Graydon, RN

The group met. 1) A presentation was done by Dr. Chris Scott and Josh Smith on the 7-day cyber incident with impacts to the EMS delivery system. 2) AB-1544 was discussed. 3) Anne Jensen provided an update on the City of San Diego Community Paramedicine Pilot program.

C. Disaster Planning Subcommittee - Paul Forney on behalf of Lisha Wiese

i. COVID-19 Update

Dr. Koenig provided an update of the most recent information on the COVID-19 pandemic. She also shared the EMCC Clinical Report which covered the following:

B. Administrative Report - Andy Parr, EMS Administrator

 EMSA Policy Update: October 17th EMSA announced a policy update regarding the termination of Governor Newsom's State of Emergency Executive Orders, (N-11-22 and N-4-22).

Effective February 28, 2023, this announcement:

- Rescinds the utilization of out-of-state medical personnel to render medical services
- Terminates waivers associated with the utilization of EMSA Cal-Mat teams Beyond 60 days of service
- Terminates EMS Personnel Licensing, Certification, Training and Scope of Practice
 waivers:
 - whereby Paramedics, AEMT, and EMT certified personnel will <u>no longer</u> be able to:
 - Perform their current SOP in hospitals, Alternate Care Sites, Shelters, or any other static site
 - Provide vaccinations (COVID, Flu, and/or MPX)

- And paramedics will no longer be authorized to Administer or monitor mAb (Monoclonal Antibody Treatments) or conduct Covid and Influenza testing
- Recruitments: We are accepting applications for Manager level positions and EMS Specialists. An EMS Specialist works with EMS agencies, hospitals, training programs and others to facilitate the innovation, sustainability, and health equity of EMS in our community, and also serves as EMT disciplinary investigators, inspectors, disaster workers, and as EMS Duty Officer. Currently certified EMTs or licensed Paramedics with local field experience are highly desirable.
- <u>Procurements:</u> The procurement for County Service Area 17 is in the final stages. The notice
 of intent to award for AMR is to continue in CSA 17. The contract has not yet been signed;
 working on that diligently.
- Virtual Meetings: The California State Legislature has passed a law (AB361) allowing partial relief from the public meeting requirements. This relief must be reaffirmed at each regular meeting held virtually. This relief ends at the Advisory Committee's discretion or until February 28, 2023, whichever comes first.
- EMS Office Strategic Plan is almost done: Thank you for your participation! The steering committee endorsed the San Diego County EMS Strategic Plan document. The Strategic Plan had received significant external review and comment. Will be posting on the EMS and County Fire website soon.
- EMS Duty Officer Notification: Reporting an EMS delivery system issue or incident to the Duty Officer is through the 619-588-0397 phone number. The EMS Office has noticed an uptick in direct, informal contacts to EMS Office staff during urgent situations. These informal updates are often important and informative, but EMS Duty Officer items need to be routed through the San Diego Interagency Command Center to ensure redundancy, active engagement, and accountability. We ask our partners to use the official notification pathway.
- EMT Renewals—submit early! In the spring of odd-numbered years, the County EMS Credentialing Team is inundated with EMT renewal applications. Agencies are asked to make sure the applications of their EMT staff are submitted early to avoid the rush. As a reminder, EMT Skills Verifications are no longer waived.

The EMS Commission met in a special session and approved the Community Paramedicine regulations. The EMS office is working hard to produce policies and procedures and get those out as quickly as possible.

C. Brown Act requirements for Teleconferencing Meetings – AB 361: A Resolution Authorizing Teleconferenced Public Meetings Pursuant to Government Code Section 54953

This resolution allows the committee to continue holding teleconference meetings for at least 30 more days. This resolution expires February 28, 2023.

D. Current CSA 69 Transition update

The final meeting of the CSA-69 Advisory Committee is today, November 17, 2022, at 4:00 pm at Lakeside Fire Protection District FS 2. The authority over the exclusive operation area will be transferred from the County to the Santee-Lakeside JPA on January 1, 2023.
