## V. COUNTY REPORT (Reports)

## A. Clinical Report – Kristi Koenig, MD

- i. COVID-19 Update
  - The County is continuing to focus on the 3-pronged approach to handle the COVID-19 pandemic.
  - 1) Flattening the curve.
  - 2) Increasing healthcare system capacity.
  - 3) Working through an Incident Command System.

Flattening the curve:

• Using non-pharmaceutical interventions (NPIs). As we open up the economy, need to do what we can do maintain physical distancing, ensure are avoiding indoor close gatherings as much as possible, and public masking as the virus can be transmitted from asymptomatic people or presymptomatic people.

Increasing healthcare system capacity:

 Doing very well on all our metrics. Remain at Level 1 (highest level) on our Capacity Plan. Starting to see increases in prehospital patient and emergency department volume and acuity. Emergency department Influenza Like Illness (ILI) very low at 2%, which is expected at this time of the year. As we start having people going out into the community more, we may see that increase, so we are watching that very closely. Also closely monitoring for the upcoming flu season. They are having mild season. Seeing decreases in many infectious diseases. Public health interventions work.

Two concerns: as we open up the county, there is a risk of increasing spread. Second concern: There is a potential for an influx of patients who are legal permanent residents or U.S. citizens who are seeking care for COVID-19 related illnesses. While have the capacity now, opening up elective surgeries will increase PPE demands and reduce inpatient care capacity. We need to stay the course and can try to reduce our risk as much as possible. We are now focusing on T3 test, trace, and treat which is a big component of what we need to have in place to put out hot spots immediately should we see increased cases as we start opening up.

There was a discussion and questions regarding testing.

# C. MOC Report – Rob Sills

Rob Sills, Public Health Preparedness Response Branch (PHPR) Chief, provided a MOC update on the following:

- Public Testing Mobile and Static Testing sites, Strike Force teams to rapidly test outbreak site.
- Medical System Capacity Continuing to support initiatives to support health system capacity
- Surveillance and Investigations T3 Test, Trace, Treat. The goal is to have the capacity to test 5,200 a day within San Diego County on any given day.
- Clinical Coordination Received the third allotment of Remdesivir from the state. 946 doses were issued to our hospitals yesterday and will receive another allotment next week.

Looking at keeping a supply of protective equipment on hand to provide to hospitals and first responders that are moving COVID-19 patients around. We are receiving some things from the state. Have roughly 480 individuals within the MOC who are responding to this with the County.

Dr. Nick Yphantides shared the latest updates on Imperial County. There were some challenges that had occurred. The San Diego/Imperial County Region is on the Federal and State radar screen. El Centro received many individuals from Mexicali, and many individuals from El Centro and Pioneers needed to be transferred out. This was due to an increase of traffic coming north through Calexico into the Imperial County Region that only has two facilities. The State has had an active role. The individuals were evacuated out of Imperial County through the State's all access transfers centers and by facility to facility transfers. Some of those individuals got transferred as far away as Santa Barbara, Los Angeles, Orange County, Riverside, and San Diego.

A group from HHSA and the CEOs from San Diego hospitals that are most impacted by the border had a virtual cross border call with the Administer of Health from Baja. Tijuana and Baja are still very delicate. Their ICU capacity has improved a little bit and yet at the same time they are opening up their regional commerce capacity.
