B. Administrative Report – Andy Parr, EMS Administrator

- 1. <u>Health Services Capacity Task Force:</u> Escalated to Plan Level 2; CDC COVID-19 Community Level is High; Southern California Fire Preparedness Level is at 2.
- 2. Change in data collection methodology for Transfer of Care: Beginning, July 1, 2022, EMS transport units will no longer be required to manually record an electronic TOC timestamp within the FirstWatch application (the "TOC button"). Instead, the receiving hospital's ePCR signature timestamp will be imported into the County EMS TOC dataset. Validation testing of the new methodology has shown the data to be accurate and reliable. Please ensure that the ePCR signature occurs at bedside when patient transfer of care occurs.
- 3. San Diego County Fire / EMS Division Advisory Committees Bylaw Updates Coming Soon! Continuing the work of moving County EMS to be a Division of San Diego County Fire the bylaws for both the CSA 17 Advisory Committee and the Emergency Medical Care Committee need to be updated to reflect these organizational changes. Please look for these DRAFT (mostly housekeeping) Bylaw changes on upcoming Advisory Committee meeting agendas.
- 4. County Meetings are Still Virtual (for now): County EMS holds several community meetings each month. Up to 6 of these meetings are so-called "Brown Act" meetings and require specific notification and recordation. The California State Legislature has passed a law (AB361) allowing partial relief from the public meeting requirements. This relief must be reaffirmed at each regular meeting held virtually. This relief ends at the Advisory Committee's discretion or until 2023 whichever comes first.
- 5. Procurements:
 - RFP for Paramedic Ambulance Service for CSA17 closes on August 1, 2022.
 - RFP for Evaluation of Base Station System and Trauma Catchment Area Designation consultant should be posted any day.
- 6. San Diego County EMS Office Strategic Plan Is Underway!: San Diego County Fire has contracted with a local firm to conduct a Strategic Analysis and to create a Strategic Plan for San Diego County EMS. This new plan will dovetail with the existing San Diego County Fire Strategic Plan and will align the strategic vision of County EMS with the strategic vision of County Fire. Representatives of selected stakeholder groups are being solicited and will be asked to join the consultant in listening sessions so their voices can be heard in support of the creation of the plan. This work will take place very soon and the timeline for the release of the plan will be this Summer.
- 7. No Meeting in August: The month of August is dark.
- 8. New EMS Address and Mailstop: USPS Mail: San Diego County EMS Office 5560 Overland Avenue, Suite 400, San Diego, CA 92123-1204. For those in the County Mail system we are at Mail Stop 202 (MS-202)
- 9. EMS Staff recruiting for new positions: Down 6 positions. Recruiting for the following: 2 positions for EMS Specialist, Administrative Analyst III, and Legal Support Assistant II. Onboarding 2 new staff on Monday: EMS Coordinator Tyler Meick and Medical Director Dave Duncan. Brian Christison promoted to Program Coordinator, replacing Adria Cavanaugh.

i. EMS Data Presentation – Josh Smith, PhD, Sr. Epidemiologist

The County of San Diego EMS Surveillance Report - Primary Metrics has a redesign and was shared with the group.

ii. EMCC Membership - Andy Parr, EMS Administrator

From the Sheriff's Department, Sgt. Mike Davis will replace primary member Sgt. Richard George; Lt. Anthony O'Boyle will replace alternate member Lt. Shawn Wray.

iii. Recent Board Action - Andy Parr, EMS Administrator

San Diego County EMS Advisory Committee bylaws will go to the Board of Supervisors in October.

A. Base Hospital/Trauma Catchment Review (Andy Parr, EMS Administrator)

The earlier RFP for the Evaluation of the Base Station System and Trauma Catchment Designation Area was not successful. County EMS hosted a Request for Information Industry Day meeting to gather information to inform our redevelopment of this important study. Should be posted any day.

B. AB 1544: Community Paramedicine or Triage to Alternate Destination Act (Brian Christison, Program Coordinator)

County staff is engaging in the process; waiting for some clarifications. Appreciation to the City of San Diego training program for welcoming County staffers and others.

C. Brown Act requirements for Teleconferencing Meetings – AB 361: A Resolution Authorizing Teleconferenced Public Meetings Pursuant to Government Code Section 54953

This resolution allows the committee to continue holding teleconference meetings for at least 30 more days.

A motion was made by Dan Froelich, seconded by Dr. Chris Scott to continue meeting virtually. Motion carried.

VIII. NEW BUSINESS

A. Consider a seat on EMCC for Air Ambulance

At the last EMCC meeting, it was decided to bring this topic to this month's meeting for further discussion on having an 18th seat on the EMCC for an Air Ambulance sector representative. Cal-AAMS will be requested to facilitate this sector representation.
