	 ✓ CCRT provided input for clients coming out of jail that are just-in-time – provide short-term stay, case management, CTI over 90 days, and low-level employment ✓ Dr. Krelstein and the Chair of Housing Council provided input regarding creating a residential, short-term case management for those with serious mental illness coming out of State Hospitals or jail Marisa Varond suggested a mobile component to support individuals on psychotropic medication who also need medication- assisted treatment

Cultural Competence Resource Team

- Piedad provided update: CCRT FY 18-19
 Accomplishments and FY 19-20 Goals has been submitted to the executive team
- CCRT reviews data in order to inform system development
- Data demonstrates disproportionality of behavioral health services within certain populations:
 - ✓ Persons getting services for the first time in jail are predominantly African American and Latino
 - ✓ 20% of the homeless population in San Diego County are African American, while 23% are Latino
- CCRT will evaluate programs to ensure adherence to CLAS Standards and review cultural competence plans in order to identify areas for further development

- Danyte Mockus-Valenzuela provided an update:
 Behavioral Health Community Engagement Forums have begun
- Forums will focus on prevention, innovations, and engagement
- Seven forums and several focus groups are being conducted to gain input from the community
- About 60 attendees at the North Coastal Forum, with more than 90% being high school students
- Central Forum will be rescheduled, new date to be announced
- January 29, 2020 from 3:30-5:00pm North Inland Forum at the Escondido Live Well Center
- Focus group comprised of high school students from four different schools will discuss substance use prevention topics
- BHS will be meeting with members of the Behavioral Health Advisory Board on January 14th to plan remaining focus groups
