MHSA Housing Program

Pipeline distributed by CSH (green handout) with MHSA and SNHP developments 3 projects in the pipeline for NPLH

- ➢ 60 units at 14th & Commercial in San Diego
- 24 units at Windsor Pointe in Carlsbad
- > 25 units at Jamboree in San Ysidro

Projects with initial commitment are invited to participate in a monthly institute CSH has started a new online reporting system with Full Service Partnerships

Used to enter in all tracking information

No Place Like Home

Innovative Housing Trust Fund

- > \$25 million initially approved by Board of Supervisors for creation and preservation of supporting housing units
- Currently in 3rd round of NOFAs with the additional \$25 million
- Reviewing total of 16 proposals

NPLH

- First NOFA released in 2018 and it closed on July 2019
- New NOFA released October 31, 2019
- Over the counter- \$40 million available for this round
- LISC Roundtable on 11/20/19- register on the SDHF website

Board and Care Committee

The Board and care model is permanent housing for adults with serious mental illness (ages 18-59) in licensed homes that provide 24/7 supervision and medication

Feasible recommendations:

- County purchase land or some existing facility and take the lead
- The possibility of the Augmented Services Program (ASP) covering a whole facility, instead of a single case agreement. ASP currently provides additional \$400 per client for those that are harder to place
- Program to incentivize owners to stay in business. Helping them with repairs, pest control, cleaning services, etc.
- > Developing a Board & Care Association, similar to the ILA
