VI.	Older Adult SOC - Updates (Piedad Garcia)	The Chair Maureen Piwowarski passed away. Piedad acknowledged Maurine's contributions. There will be a small gathering to celebrate her in Balboa Park at the end of October. Hep A has been declared as a local emergency in San Diego. Focus of attention is Central Region but we focus on South and East regions as well. There are different approaches to the outbreak. From BHS services prospective we have been immunizing clients and public. We have some shortage in nurses. We are looking at the data to utilize program and county hospitals nurses. A training will be provided and the proper set up is necessary — refrigerator to keep he vaccine in proper temperature etc. The Hep A is spreading outside County of San Diego. It is an obligation of the community to do something for the outbreak as well. It's a collaborative effort form the Government and the community. There was a suggestion to incentivize the homeless to get the vaccine — food, gift card etc. We need to think outside the box and bring the outreach to pharmacies, faith based places, churches etc. Project "No Place like home" is coming up in a year.
