I. Call to Order

II. Approval of the Minutes from February 22, 2024

III. Hearing from the Public

- Janice Luna-Reynoso expressed appreciation and acknowledgment of improvements made in responding to the resource needs of flood disaster victims. - Judith Yates stressed that we need to be more prepared for the next disaster and questioned the delay in response for flood disaster victims.
- Robin Sales stated that the presentation by UC San Diego Health Partnership to the BHAB subcommittees participants was a success and stressed the need to make connection points between the input received for the Community Program Planning (CPP) process and BHS program planning.
