V. Subcommittee Chairs

BHAB Chair, Robin Sales, provided updates on the recently established BHAB subcommittees and provided the following updates:

- The Justice System Nexus with Current Behavioral Health Issues Through a Racial Equity Lens Subcommittee and the Participation & Partnership Subcommittee have designated their respective Chairs and will meet monthly.
- There was expressed need for a Chair for the newly established Substance Use Prevention Subcommittee, formerly known as the Alcohol and Other Drug (AOD) Subcommittee. Bill Stewart volunteered to Chair this subcommittee.
- Robin suggested the possibility of integrating the Substance Use Prevention Subcommittee into the two active subcommittees due to their overlapping priorities and the need for those subcommittees to have input from substance use prevention stakeholders.

VI. Membership and Vacancies

BHAB Chair, Robin Sales, provided the following updates:

- Robin Sales announced the resignation of BHAB member, Carol Clemens from District 5, effective May 3, 2024. A
- Newly appointed BHAB members are expected to attend the general BHAB meeting on May 2nd, from 2:30pm-5:00pm. New members have been appointed to vacant seats in District 5 (one new member) and District 4 (two new members).
- Currently, there are three (3) vacancies in District 5 and one (1) vacancy in District 2.

Dania Barroso-Conde gave an update regarding the addition of a statutory requirement to the seat categories on BHAB which will include a Transitional Aged Youth (TAY) seat on BHAB. The appointment of a TAY member will have to follow State statutory, County Ordinance, and BHAB bylaw requirements and will have to abide by Brown Act rules.
