Department of Homeless Solutions and Equitable Communities Office of Homeless Solutions (HSEC-OHS) Program Reference Guide

The Department of Homeless Solutions and Equitable Communities, Office of Homeless Solutions (HSEC-OHS) focuses on collaborative and coordinated outreach and case management services via multi-disciplinary partnerships to assist people experiencing or at risk of homelessness. In addition to providing direct services HSEC-OHS also works on planning, developing, and implementing programs that serve specialized populations of people experiencing or at risk of homelessness.

HSEC-OHS Regional Homeless Services**	✓ ✓	HSEC-OHS Regional Homeless Services are multi-disciplinary teams of outreach staff that connect individuals to self-sufficiency programs (CalFresh, CalWORKS, Medi-Cal, General Relief), social workers that provide case management and housing navigation, and two Licensed Mental Health Clinicians that provide clinical case management, as well as consultations to their peers. These teams are the lead outreach entity in the Unincorporated areas of County and partner with City jurisdictions' multi-disciplinary outreach teams, community partners, Caltrans, MTS, and North County Transit District to provide services countywide.		
Housing and Disability Advocacy Program (HDAP)** Regional Homeless	✓ ✓	Services are provided Countywide. Referrals into program are made by HSEC-OHS Regional Homeless Services staff who identify clients that meet the program criteria. Provides people who have a disability and are experiencing homelessness or at risk of homelessness with case management, housing subsides, and benefit legal advocacy while they go through the process of seeking financial benefits from SSA or VA. Services are provided Countywide. Referrals into program are made by HSEC-OHS Regional Homeless		
Assistance Program (RHAP)**		Services staff who identify clients that meet the program criteria. Emergency housing program for people experiencing homelessness in unincorporated County.		
Specialized Funding for Imminent Needs (SFIN)**	√	Services are provided Countywide. Referrals into program are made by HSEC-OHS Regional Homeless Services staff who identify clients that meet the program criteria. Reduces immediate barriers to housing, help expedite housing placements, and increase housing stabilization for individuals and families experiencing homelessness or at risk of homelessness.		
Magnolia Safe Parking**	✓	Safe Parking operated by County contractor Dreams for Change that offers overnight parking for people experiencing homelessness with support services (housing navigation, meals, flexible funding) Primary service area is Unincorporated San Diego County and referrals are made by HSEC-OHS Regional Homeless Services who identify clients that meet the program criteria.		
Bancroft Safe Parking**	√	Safe Parking operated by County contractor Dreams for Change that offers overnight parking for people experiencing homelessness with support services (housing navigation, meals, flexible funding) Primary service area is Unincorporated San Diego County and referrals are made by HSEC-OHS Regional Homeless Services who identify clients that meet the program criteria.		
By-Name List	✓	Contracted to the Regional Task Force on Homelessness which is training jurisdictions on how to operate a by-name list and to identify people experiencing homelessness in their communities who have been prioritized through coordinated entry to assist them with local resources.

HSEC-OHS Contracted Programs				
HOME Program	√	24-month rental subsidies for transitional aged youth experiencing homelessness. Program receives referrals from Housing Our Youth program.		
Inclement Weather Program	✓ ✓ ✓	Provides temporary emergency hotel/motel shelter during periods of inclement weather in one of 7 zones across unincorporated San Diego Inclement weather includes excessive heat, cold or rain. Referrals into program during inclement weather episodes are received by 211 Home - 211 San Diego		
Local Rental Subsidy Program	✓	Temporary 24 housing subsidy vouchers are provided to qualified individuals who are exiting the Compassionate Emergency Solutions and Pathways to Housing (CESPH) programs such as RHAP and Safe Parking.		
Housing Stability Case Management Program	√	Participants receiving the LRSP are offered housing stability case management to support their long-term housing stability and retention for up to the duration of their housing subsidy.		
Home Safe	✓	Services are provided Countywide. Referrals into program can be made through County's Adult Protective Services hotline 1-800-799-7233 HSEC-OHS in partnership with HHSA Aging and Independent Services (AIS) provides case management and housing support to older adults that have been referred through the Adult Protective Services (APS) hotline and are experiencing homelessness or at risk of becoming homeless.		
Homeless Diversion	✓	Contracted to the Regional Task Force on Homelessness to administer \$300K in funding through diversion services. Diversion services are delivered through RTFH existing contractors for clients who are already accessing contractor's existing services.		
Pilot Shallow Rental Subsidy Program (SRSP)	√ ✓	Program is serving 380 senior households with \$500 monthly subsidy paid directly to landlords Referrals are not currently accepted as program has reached capacity.
