So even up to today, Dr. Keeler Weber's Assembly woman, Weber's team is always reaching out to me to help pull things together, so they have a turkey giveaway coming up this Saturday, and so I reached out to Java providers and champions for help to make sure that they are there to do covid and food vaccines. So, I'm kind of the conduit. But I also want to make sure that the community knows that our health care at the Jackie Ronson, YMCA. Has vaccines, and they have for the last from. We started 2 and a half years ago. So, it's a little litchi now, because we're you know, the county provides for the underserved and under resourced, and then so chances for Champions of Health to get the private ones to be able to offer both at the event. They've been all over the place, so you know, it would be nice to have 2 or 3 others, so we're not beating up champions for help all the time. But whoever it is, we want to make sure that they're going to partner well in the community and not forget the small potatoes like myself, who make sure they're going to serve the community like every single month. Question: Dr. Suzanne - nurses. The county nurses over the years in the past, when they would come out and get Pepe vaccines and flu vaccines before champions for help came on board. We drag the county nurses out ECC and big lots, and wherever. So, II scrap and beg, and whoever has the vaccines, I'm willing to ask them to come, and everyone's been gracious enough to be there to serve the community, because we are serving a very underserved community of color. And so, we get better bang for our Buck, and now they're looking for it. So, I feel very disappointed that I've had to tell them 2 times. No, sorry we don't have it, so we got to fix that glitch so because they relied on us to just come and get their vaccines.

Answer: Jeff – kind of like, I'm just champions for health, currently doing about 4 to 5 a day up to even 7 days a week, and I do know that they have made their rounds all throughout the county, different needs or events, or things like that. I do know we have active foot teams from the agency up in the North County area, with some of the homeless encampment's there all over the county.

Question: Tim- I would say from the vaccine part, getting access to covid vaccines, in the first place, it's also on the reimbursements side it, making it harder and cost going up. And we're finding most of our patients are not wanting it. So, we're actually outsourcing a lot and telling them to go to the local pharmacy because they have better access for it and for the patients that do want it. Otherwise, it's kind of sitting on our shelves being out there. And we've given a lot more flu vaccines, and we have covid vaccine. we may be calling upon you and some of our fares because we don't want to go out, buy all the vaccine and have it just sit. And first. So, it's good to know this. Be curious to get the information to be able to get to the health centers, because we are just kind of pushing them out right now. So, we also, I think one of my members got 40 vaccines for the bridge through the bridge program. So, I mean, it's been hard to get access to at a reasonable cost. As well make it easier. But you may also be running into the same problem. But if you get it.

Comment: Carol- on the Covid vaccines. Most people are dying. But I think that most people, and even people who should know better. I'm thinking, my fellow dentists and other people that you know I talked to when they've gotten Covid recently, and you know, have you had a vaccine that they haven't? Don't kind of get that. The latest vaccine is to a different bug. I mean if you had the earlier vaccines. You don't have the latest vaccine. You're not really immunized against something that's close to what the disease is now. And so many people just think. Well, I've had so many vaccines. Nobody's dying. So, to me. There's like a huge gap right now, and maybe it's not as urgent because people aren't dying so much, but still, its morbidity is people who are sick people who are spreading it. I mean, it's just not good, and they don't get that. And they don't get that. Oh, they don't have it in their in their doctor's office. So, there's going to wait for months. Why is it? Just go online and go to CVS. I mean they don't. They don't understand this. I think that there's a whole piece on education that I wish that that was happening. And maybe the county can help in this to get that information out, because people believe who should know better.

BOARD DIRECTION

- On June 8, 2021 (3), the Board voted on the American Rescue Plan Act framework which included the following \$20M for food assistance.
- On January 25, 2022 (5), the Board approved implementation of the Sustainable, Equitable, and Local Food Sourcing Program; and directed the development of a Sustainable, Equitable, and Local Food Sourcing Policy and a return to the Board to provide the policy framework.
- On June 14, 2022 (3), the Board received the Sustainable, Equitable, and Local Food Sourcing Program and Policy Framework and authorized a return to the Board within 18 months for consideration and adoption of the final Sustainable, Equitable, and Local Food Sourcing Policy, and economic assessment which will be brought to the Board on December 5, 2023.

Food Assistance Programs: \$20M

Question: Tim- and there was a state bill to have medical cover all prescription drug prescription for food. I don't know for past them. I'd have to look back at the end of the cycle. But they're making strides. Be able to do that because to talk to father's point now, when they have access to the healthy food, they are. coming out much healthier outcomes and going through. My question was on what they had to fill out, because you had several may provide information on and on that there were 3 on cost. And if we want this to be a sustainable program, we want to make sure that it's being done. We need to collect how much each one is paying within the locally sustainable food, because at some point the whole point is to make sure we increase access to food, and that. you know, II tend to go to certain stores that pay a lot more for produce than in other stores. We want to make sure more people can gain access and understanding how much they are now paying some of these local farmers and other to produce, and whether, we can find other vendors that will provide similar food at a lower cost. It's going to be important for this, so I would think, instead of having it in May. that you change that to certain requirements, and then others being additional, but cost the biggest part, and you should be tracking it, and we all work in grants. We all take funding, and it's just a reality. If you want to take the money, you must fill out the reports. The Question is will you change it?

Answer: Paul — So I appreciate the local sources. We all start with soldier and covid. How fragile our food supply network is. And we had crops and farmer's animals and went to waste because they didn't have the workers at the time. to process his products. But, more importantly, we're seeing as national change are starting to coalesce and merge. that you have the larger chains of buying power to control a lot of these products. And then we have these food deserts all over Sandy, accounting where either you can't afford it at some markets, or you can't even get that that quality product. So, the local sourcing is important. So, congratulations. That's one of the priorities.

Question: Tim- you said this is all being done with our funding, so we all know our funding is limited funding and is going away. You have a couple of years spend which it lines up. What are the plans? Once this program is established and started to keep the program going beyond the 2 years of our well, December fifth, to
