#### **CONTEXT & OPPORTUNITY**

- On October 24, 2023, the Board previously authorized acceptance of an estimated \$1,312,584 CDC grant subaward from UCSD for the period of September 30, 2023, through September 29, 2028, to improve preparedness and response to infectious disease through data, modeling, and analytics.
- Subsequently, the CDC made available to all U.S. grantee locations an additional funding opportunity.
- UCSD, with support from County of San Diego, Public Health Services, applied for and was approved by CDC for additional funding of which \$425,000 is allocated to County of San Diego, Public Health Services.







#### **Questions and Answers:**

**Barry Jantz:** Dr. Coleman, it's Barry Jantz. Just out of curiosity, what can you tell us about any information about any organizations that are looking at masking again or anything like that. I heard some private sector folks were doing it, I heard some hospitals were doing it, but I--

**Dr. Coleman:** That's actually a great question, Barry. I know that in my discussion with Dr. Kadakia, I don't think she is at the point of contemplating making mandatory masking again. My wife is a social worker at one of the local hospitals, and I think they've gone back to masking, but it's not mandatory at all. I think the data would ultimately tell us, you know, what interventions might need to be taken. But obviously masking is a very important intervention. Any of us can mask at any point voluntarily, so I would encourage that if needed. We're sort of going back in time in many ways to the interventions that we use when the public health emergency, you know, was intact in terms of, as Adrian said, she was trying to be very thoughtful today. She had a COVID exposure yesterday, so she felt rather than come into the meeting that, you know, she would attend remotely. It's the same situation. If you are symptomatic, even if

it's not--you're not running a fever. I remember an MMWR a long time ago during the active pandemic, you know, that there was an adolescent that had allergy symptoms that ended up being positive. So the availability of PCR testing as well as at home testing is still very applicable. You know, certainly consider, you know, if you want to limit any of your activities. But at this point, it's really more voluntary interventions as we know that, you know, this surge is particularly occurring. The other thing I will tell you is that it will be in the fall, the Advisory Committee on Immunization Practices recently approved the COVID immunization that will be upcoming in the fall. I know that Moderna was looking at a joint flu shot and COVID shot. That won't be on the market this year, but the recommendations will be for immunization in the fall, six months and older for both flu and COVID that will be able to be obtained at the same time. So that's what's to come right now. It's still making sure you're up to date on your immunizations and then all of the different interventions that we've all come to know very well.

Dr. Seldin: Do you know specifically when the new COVID vaccines will be available this fall?

**James Lepanto:** This is James, and Dr. Seldin was asking the same thing. I've heard the same thing and I've had a lot of people ask me because they know I'm on the board, like the vaccine expert, but when in the fall do you--do we have any projections of when that will be available in the fall?

**Dr. Coleman:** That's a great question, James and Dr. Selden. We're hopeful it'll be around the time of when flu shots would be available. So probably sometime September to early October. I saw that Adrienne nodded. I've not heard anything definitive. I know that the ACIP, as I mentioned, has approved the strains that will go in both the flu and COVID vaccine. I'm not aware of any overt timelines that have been disseminated so far.



**Dr. Coleman:** Yeah, I was just reinforcing--I saw that the PEI board letter was there. So letting you know that we'd be back next month. I anticipate Ronda will probably be presenting that.

Dr. Bhatia: Thank you. Any questions on that?

#### **VII. ROUNDTABLE**

**Geysil Arroyo**: So I work at the SDSU School for Public Health. And we're working--the director of the School of Public Health and myself--on coming up with a summer experience for high school students to get their hands on public health projects. And we're very early on. So one goes to the internet and tries to look up information. And I came across this flyer from a program called Peer Public Health Advocate Camp.

James: One is, can we remind presenters to [include a discussion of equity?] I have been meaning to bring this up for a while and ask the County [to remind speakers to make sure they're including [the equity piece in their presentations.] The second thing is a frustration. Anuj is familiar with this. Suzanne is familiar with this because [inaudible]. There is a young woman who is eager to get involved with us and was looking at a way to become involved two years ago. We're now two years in. We thought of having her as Dr. Afflalo's alternate. [inaudible] for the life of me. This is not anything to do with Anuj. Anuj and the Department [have done everything they can to move this along.] We have sent emails, we have made contacts. I don't know if this is the Board of Supervisors. I don't know if it's the Clerk of the Board. It does not have anything to do with the department's issue. They've been very helpful in us trying to do this. But, you know, in all honesty, excuse me, this is damn embarrassing. For once we have someone coming to us that wants to be on the board, and it is taking two years now and we cannot get this [done]. So Anuj, not to put you on the spot, but [what can be done to expedite this process?]

**Barry Jantz:** And of course, the way I understand it, if this is a processing issue, if it's primary appointment, it goes to the Board of Supervisors, and it seems like that would even be a simpler process, is simply that particular supervisor saying, "Yes, I'm OK with this alternate."

**Dr. Bhatia:** I understand, yes, we will be following up and we will be communicating the message.

**Dr. Seldin:** I just have a question. This is mostly for Anuj, and maybe others. You were talking before in the kind of quasi, the presentation that is partially virtual and partially here, about the National Association of County Health Officers, or health something, but it made me think back to the National Association of Counties, NACo, Acts of Caring Awards, are those still happening? I was just thinking I hadn't heard anything in a long time. And I remember this because I got one at the time. It's, let's see, 15 or 20 years ago almost, that it was a collaboration with the County and the Dental Society. And it was a big deal, and it was fun. I haven't heard anything about those in a while. Is that still happening? We're talking about getting people involved, and to me that's like a great thing to highlight a lot of different things. Collaborations between the nonprofit and private sector, or private sector and government. Is that still happening, because I haven't heard anything in a long time.

**Dr. Bhatia:** I would need to look into that. I'm not sure if it is. I haven't heard of that [inaudible], but it's something we can look into to find out and let you know.

**James Lepanto:** I think it's still around.

**Dr. Seldin**: I recommend that people apply for that and that's sort of a combination of County staff and outside groups, but there's a lot of different collaborative activities going on, so it's nice to have that visibility and have that highlighted. So it may be happening, and maybe someone at the County that is involved, I just haven't heard anything

	in a long time. I mean, it wasI was justthe whole thing of that, it all together, was such a positive experience, and I
	would hope that [indistinct] and we have so many things happening now that there would be ways in which that could
	be another thing, and recognizing at the community level, but then some of that gets recognized at higher levels.
	<b>Barry Jantz:</b> Anuj, so you can follow up. Thank you. An email went out from Anuj today reminding folks that if they were appointed after May 24, 2022, who have not received the required orientation, that there's a[n] option to do that coming up in October. So if you have questions on what the requirement is, or if you didn't get the email, or you need to focus on the email to see what it says exactly, but I think that's it. Basically, if they're appointed after May 24, 2022 and have not received the required orientation, then there is an orientation session on October 2.
	<b>Dr. Bhatia:</b> And there have been similar trainings offered in the past, and so if you cannot make it to this one, there will be others offered in 2025. So I know some of you have taken it. But the concern is that we make sure that the number of members who take the training once it's [inaudible] training does not constitute a quorum for the HSAB. So
	we need to make sure it's less than 8 members taking this.
