



# Community Assessment for Public Health Emergency Response (CASPER)

- Interview households to assess short-term and ongoing impacts on their lives
- Information distributed to almost 7,000 households in early October
- Conducted household interviews October 17-19
- Results are pending CDC analysis and clearance



# Tijuana River Valley Crisis Response

#### **Assessment of Chemical Exposures (ACE) Survey**

- CDC/Agency for Toxic Substances and Disease Registry (ATSDR)
- Interview people who work in high exposure areas or come in frequent contact with sewage pollution
- Exposure histories, related symptoms, health impacts, health services used, and medical history will be elicited
- 1000+ surveys completed!




