



# Why a Needs Assessment?

 Despite dramatic increases in older adult homelessness, little to no attention from elected/appointed officials, the public and philanthropy.

 Applied for and received \$100k grant from the Hearst Foundation to conduct comprehensive needs assessment.



# **Key Findings**

- Homeless due to lack of an economic safety net, catastrophic event
- 56% need \$300 or less of monthly income to increase their rent security
- Avoiding shelters
- Less than 45% of service providers have gerontological training

"Older adults possess specific age-related obstacles contributing to their risk of becoming homeless."

### **Shallow Subsidies**

- Transitional/buy time must find permanent housing solution (e.g. vouchers, other affordable housing).
- Rents paid directly to landlords don't want to jeopardize other income related benefits
- Challenge: what happens when subsidy runs out without a housing solution?
- Diversion an option

### **Shallow Subsidies**

- County Board of Supervisors
  - Bipartisan support
  - \$500/month subsidy
  - Target: seniors below 30% AMI; rent burden 50% or more
  - \$2 million/ARPA funding for 18 months plus evaluation
- City of San Diego
  - Same AMI/income ratios as County
  - \$2 million in shallow subsidies approved for second year funding
  - Subsidies: \$250/\$500/\$750
  - Challenge getting rent to income ratios below 70%

# **Shallow Subsidies --- Philanthropy**

- Community Congregational Development Corporation (\$352k)
  - Provided 255 unduplicated seniors with supportive case management services.
  - Provided 99 referrals to other services and resources such as utilities assistance and transportation.
  - Provided 28 unduplicated low-income seniors with shallow rental subsidies and intensive case management.

Dear Chairwoman Stabenow, Ranking Member Boozman, Chairman Thompson, and Ranking Member Scott:

On behalf of the County of San Diego, and the 3.3 million residents who call our region home, I would like to share with you our priorities and recommendations for the 2023 Farm Bill. Though San Diego is known for our beaches and coastline, our \$1.75 billon agriculture economy with about 5,000 small farms remains a vital economic engine for our region. At the same time, like many other large counties, 1 in 4 San Diegans are identified as food insecure. The nutrition title of the Farm Bill provides many vital nutrition lifelines to so many residents in our County. The Farm Bill reauthorization process provides Congress an opportunity to lay out its policy direction for the next five years, policies aimed at addressing food insecurity, agricultural trade, conservation efforts, agricultural research, and farming communities. Compiled below are the County's priorities for the 2023 Farm Bill, priorities we hope the respective committees of jurisdiction will consider as they craft and negotiate the final piece of legislation.

#### **Nutrition Programs**

The County of San Diego administers CalFresh, California's Supplemental Nutrition Assistance Program, and other assistance nutrition programs. Over 350,000 San Diegans are enrolled in SNAP, with thousands more eligible who are not electing to receive the benefit. For some, it is a lack of outreach that leaves many unaware they qualify for the benefit, while for others more stringent requirements or time limits leave many feeling it is not worth their time to apply for

programs like SNAP. With emergency SNAP allotments ending earlier this year and with new work requirements changes to SNAP, there is a greater need not just for a robust benefit amount, but increase in outreach efforts. The County encourages the committee to consider the following:

- Keep in place recent Thrifty Food Plan recalculation and provide funding to ensure SNAP benefit keeps pace with inflation
- Allow state waivers that expand access to SNAP to remain
- Retain Broad-Based Categorical Eligibility, which allows many San Diego families with low incomes to be eligible for SNAP
- Expand resources for SNAP-Ed programs, especially resources for states to conduct outreach to populations now exempt from work requirements
- Remove barriers to access SNAP for college students by including attending college part time as a form of acceptable work to meet work requirement standards
- Increase limits on income to reflect higher cost of living in states like California
- Modify the earned income limits to only count net income, rather than gross income, towards SNAP qualification
- Expand allowable expenses to align with basic needs for the 21<sup>st</sup> century such as the cost of internet access

#### **Animal and Plant Health Programs**

San Diego County is a major port of entry for goods, whether it's across the border with our neighbor Mexico or through our Port. However, with this vast amount of trade comes an increased risk of invasive species and diseases.

- Support continued and increased funding for the Plant Pest and Disease Management and Disaster Prevention Program.
- Support pest prevention and exclusion system coordination across Federal, Tribal,
   State, and County programs that effectively prevent and eradicate invasive agricultural pests.
- Increase funding necessary to optimally support California's Detector Dog Team Program.
- Support increasing investments in nutrition and food assistance programs to address food insecurity, strengthen local/regional food systems, and support the overall health of individuals.

#### **Conservation Programs**

The natural beauty of San Diego County is the result of careful conservation and thoughtful policies. Conservation programs included in the Farm Bill should keep their robust funding in order to help localities further our conservation and climate goals.

#### Research

As the climate changes and new pests emerge, research support remains a vital component to the Farm Bill. In San Diego County, it is important to make sure that our agricultural economy is best prepared for the environment of the future by supporting research in agricultural science.

#### **Rural Development**

When many think about San Diego, often what comes to mind is our beautiful coastline and beaches. However, a significant part of San Diego County is deemed to be rural. Diminished access to broadband internet remains a problem for rural businesses, health care providers, and public safety. As the County also looks to increase the electric car charging infrastructure in rural communities, ensuring access to high-speed internet is essential for the growth of charging infrastructure outside urban or densely populated areas. Rural development programs in the Farm Bill, including funding for broadband, are essential to address longstanding equity issues.

The County of San Diego urges you and your fellow committee members to consider these priorities in this year's Farm Bill reauthorization and urge speedy consideration of the legislation in order to ensure there is no delay in the vital services funded by the Farm Bill.
